a little bit as well um

am i missing something Holly, okay but
we're going to tell you that we are

going to make our school available
to you at 7:15 in the morning

if i were a kid and school doesn't start

i would think mom dad don't make me

uh lots of uh lots of hands to get uh

students out we are going to begin that
at 10:50 at least on black and white

we're saying that
i imagine we will be a lot earlier than

00:15:48.240 --> 00:15:52.720
that to get them
uh together and to work their way out to

00:15:52.720 --> 00:15:56.480
their area i want to tell you that
during this time

every teacher will be escorting their
entire class

out to every spot a child
can be dropped off, a car, the teacher

00:16:06.399 --> 00:16:09.440
will
hand it over to the car rider area to

the bus area to the walkers area
if they're in after school care they

will be
handed over during these times, one of

00:16:18.240 --> 00:16:21.920
the things that we said
as kids are leaving the building and for

a while it's going to look robotic
it's going to look controlled uh we are

00:16:27.199 --> 00:16:31.120
going to ask
the students to behave as if they are

00:16:31.120 --> 00:16:35.440
in a fire drill which has the standard
you've done a million

00:16:35.440 --> 00:16:38.560
million of them yourselves where you
don't talk

00:16:38.560 --> 00:16:42.959
and you stay in the straight line and
we're going to insist on that early

00:16:42.959 --> 00:16:46.079
until we get more comfortable making
sure we can

00:16:46.079 --> 00:16:50.000
socially distance and train the
behaviors that will

00:16:50.000 --> 00:16:53.600
make it so kids can be safe uh among
each other

uh let's see

let's see all staff of you yeah, i think
all the details are covered there we

00:17:02.959 --> 00:17:09.039
we have a map that describes our
dismissal routes at least on day one

it seems like a good idea we'll find out
when we have people in the building

exactly how it works we have this great
fortune at Cedar Creek that we have

00:17:18.400 --> 00:17:23.600
many many exterior doors so we don't
have to congregate our kids

00:17:23.600 --> 00:17:27.360
funnel them through one spot and get
them out, a few students will

00:17:27.360 --> 00:17:31.360
use the main entry but we'll get them
outside as quickly as we can

and guide them as a group of students
who are pretending they're in a fire

drill
socially distanced six feet away so we

00:17:40.400 --> 00:17:45.039
can drop them
exactly where they need to be, put them

00:17:45.039 --> 00:17:48.080
where they need to be
and make sure they get get out and on

00:17:48.080 --> 00:17:52.400
their way Holly will describe the car
rider pickup area

Holly Reid: so if you've picked up a student from
cedar creek before through the car rider

00:17:56.160 --> 00:17:58.640
line
usually we have all of our students

00:17:58.640 --> 00:18:02.559
waiting under the awning
that you see on the screen here

00:18:02.559 --> 00:18:06.320
unfortunately that's not
a very big space so we are going to be

00:18:06.320 --> 00:18:09.360
extending that over and our fourth and
fifth grade car riders

00:18:09.360 --> 00:18:14.480
will be waiting in the sidewalk area
that runs between the bus lane and the

00:18:14.480 --> 00:18:17.039

parking lot just to allow for a little more room

00:18:17.039 --> 00:18:20.240
additionally we'll have markers out there so the students know exactly where

00:18:20.240 --> 00:18:23.919
to sit while they wait for their car you can help us out by being on time to

00:18:23.919 --> 00:18:27.200
pick up your students so that we minimize the amount of time

00:18:27.200 --> 00:18:30.400
that they are waiting there

00:18:30.960 --> 00:18:35.200
Brad Wirht: great uh this is just tell you that we've thought about it

00:18:35.200 --> 00:18:38.240
we're not really going to go through it deeply

00:18:38.240 --> 00:18:42.160
again i'm going to reinforce what Mrs Reid said about

00:18:42.160 --> 00:18:45.760
you know your timeliness is real helpful to the whole staff

00:18:45.760 --> 00:18:49.600
they're all dashing to other duties as soon as schools

00:18:49.600 --> 00:18:53.760
the children are gone at 11 o'clock and those students who are

00:18:53.760 --> 00:18:58.320
waiting around we're not going to leave them unsupervised but we will be

00:18:58.320 --> 00:19:04.000
uh give you time to get here close to 11 10 minutes later we'll we'll bring them

00:19:04.000 --> 00:19:08.080
to the office
and we will um uh help connect with you

00:19:08.080 --> 00:19:13.039
and
and hope that it's a one-time event

a parent pick up during the school day
again it's going to be very regimented

00:19:17.919 --> 00:19:22.080
you'll
ring the bell, we'll bring you in we'll

00:19:22.080 --> 00:19:25.919
check your ID to make sure you're the
right person to pick up a student

00:19:25.919 --> 00:19:29.440
and then we'll ask you to clear back out
of the office area

stand in the entry, even better, stand
outside and then

00:19:34.000 --> 00:19:38.559
a staff member will bring your child to
you uh

00:19:38.559 --> 00:19:44.160
so i'm gonna jump on this real quickly

also group and partner work that's still going to exist in our educational
