IMPORTANT DISTRICT NOTICES

Student Directory Information

Student directory information is considered "public" under state and federal laws. Unless parents give specific instructions to the contrary, schools must release directory information to anyone who requests it.

Public directory information includes, but is not limited to: the student's name, photograph, major field of study, dates of attendance, grade level, enrollment status (i.e., full-time or part-time), participation in officially recognized activities and sports, weight and height of members of athletic teams, degrees, honors and awards received, and the most recent educational agency or institution attended.

If you do not wish for this information to be given out about your child, send written notification including: name of the student and/or parent, if applicable; home address; school presently attended by student; parent's legal relationship to student, if applicable; and specific categories of directory information to be made not public without the parent's or eligible student's prior written consent, which shall only be applicable for that school year. Notification should be sent to: Restrict Directory Data, White Bear Lake Area Schools, 4855 Bloom Ave., White Bear Lake, MN 55110, no later than Friday, October 16, 2020.

Release of 11th/12th Grade Data to Military Recruiters

Federal law requires high schools to provide military recruiting officers access to public directory data (above) and the names, addresses and home telephone numbers of all 11th and 12th grade students. Parents have a right to refuse release of this data by sending written notification to: Refuse Release to Military Recruiters, White Bear Lake Area Schools, 4855 Bloom Ave., White Bear Lake, MN 55110, no later than Friday, October 16, 2020.

It is the expectation of the White Bear Lake Area School District that families, students and staff will self screen at home before coming to school.

Anyone experiencing ANY of these symptoms should NOT attend school:

New onset cough or shortness of breath by themselves

OR at least 2 of the following:

- Fever (100°F or higher) or Chills
- Headache
- Muscle Pain
- Sore Throat
- Fatigue
- Congestion
- Loss of Sense of Smell or Taste
- Gastrointestinal Symptoms (diarrhea, vomiting, or nausea)



Free/Reduced Lunch Applications

Apply today for Free/Reduced Lunch Dear White Bear Lake Area Schools families.

Our school provides healthy meals each day. Breakfast costs \$1.70; lunch costs \$2.70 for elementary students and \$3.00 for secondary students. Your children may qualify for free or reduced-price school meals. Please apply online or complete the enclosed Application for Educational Benefits following the instructions on the back. *A new application must be submitted each year*. At public schools, your application also helps the school qualify for education funds and discounts.

State funds help to pay for reduced-price school meals, so all students who are approved for either free or reduced-price school meals will receive school meals at no charge. State funds also help to pay for breakfasts for kindergarten students, so all participating kindergarten students receive breakfasts at no charge.

My child's application was approved last year. Do I need to fill out a new one?

Yes, your child's application is only good for that school year and for the first 30 school days of the new school year.

Why is it important to turn in the free and reduced lunch application by the end of September? If you do not submit the form and aren't able to pay your lunch bill, the federal government may not reimburse your school for all of your child's meals. Additional benefits may be available to students who qualify for free or reduced lunch, such as lower or no fees for activities, some field trips, testing and more. Also, in order for your school to receive extra federal funding (which can keep classes small) our district must submit your application to the federal government by October 1. Applications sent to the federal government after that time will not help schools receive extra funding. In short, your school loses money.

Who can get free school meals?

Children in households participating in the Supplemental Nutrition Assistance Program (SNAP), Minnesota Family Investment Program (MFIP) or Food Distribution Program on Indian Reservations (FDPIR), and foster, homeless, migrant and runaway children can get free school meals without reporting household income. Alternatively, children can get free school meals if their household income is within the maximum income shown for their household size on the instructions.

Common Questions

I get WIC or Medical Assistance. Can my children get free school meals?

Children in households participating in WIC or Medical Assistance do not automatically qualify for free meals. Children may be eligible for free or reduced-price school meals depending on other household financial information. Please fill out an application.

Who should I include as household members?

Include yourself and all other people living in the household, related or not (such as grandparents, other relatives, or friends).

May I apply if someone in my household is not a U.S. citizen?

Yes. You or your children do not have to be U.S. citizens for your children to qualify for free or reduced-price school meals.

What if my income is not always the same?

List the amount that you normally get. If you normally get overtime, include it, but not if you get overtime only sometimes. For seasonal work, write in the total annual income.

Will the income information or case number I give be checked?

It may be. We may also ask you to send written proof.

How will the information be kept?

Information you provide on the form, and your child's approval for meal benefits, will be protected as private data. For more information, see the back page of the Application for Educational Benefits.

If I don't qualify now, may I apply later?

Yes. Please complete an application at any time if your income goes down, your household size goes up, or you start getting SNAP, MFIP or FDPIR benefits.

Discover School Breakfast!

Did you know:

- White Bear Lake Area Schools serve breakfast daily, which costs \$1.70. That is less than at the convenience store and it includes whole grains, fruit choices and milk.
- There is no charge for Kindergarten, Free and Reduced-Price Eligible Students.
- Eating breakfast gives your brain energy to think clearly in class and gets you "charged up" for the day.

Instructions

The Free and Reduced Price Meal Application will be available online each July.

To see if you qualify, go to the White Bear Lake Area School District's website at *www.isd624.org* and follow the steps below:

- At the top of the page click on "Our Schools" and select your child's school.
- On the school home page select "Support" in the dark orange bar at the top of the page.
- Select "Free/Reduced Lunch." This will take you directly to the online application.
- Once you are there, create or login to your account and fill out the application and hit the "submit my application" button.
- Visit the Nutrition Services website (https://www.isd624. org/departments/nutritionservices) for an instructional video and quick card.

The **Richard B. Russell National School Lunch Act** requires the information on this application.
