Transporting Passengers Safely



Vehicle Inspection for a City Bus



**Please remember: This section refers to any passenger CMV and not necessarily to a school bus. The vehicle inspection is not up to ACPS standards, but you must familiarize yourself with the following for DMV CDL standards:

- Tires on the **<u>front</u>** of a bus must not be recapped or re-grooved.
- Interior parts to be checked: handhold railings, floor covering, signaling devices, emergency exit handles, seats securely fastened.
- <u>Never</u> drive a bus with an "Emergency Exit" sign door or window open.
- However, you may LOCK some emergency roof hatches in a <u>partly open</u> position for fresh air.





Hazardous Materials

Do not transport any hazardous materials unless you are sure the rules allow you to do so.

Buses MAY carry:

- Small arms ammunition labeled ORM-D
- Emergency hospital supplies and drugs
- "Small amounts of some other materials if the shipper cannot send them any other way" DMV manual Page 4-2





Forbidden Hazardous Materials



Buses must never carry:

- Division 2.3 poison gas
- Liquid class 6 poison
- Tear gas
- Irritating material

Riders are never allowed to carry on common hazards such as car batteries or gasoline.

- More than 100 pounds of solid Class 6 poisons
- Explosives in the space occupied by people

More than <u>500</u> pounds of total allowed hazardous materials and no more than <u>100</u> pounds of any one class

For Safety Sake

• **Standee Line:** All riders must stand behind the Standee Line



- Charter buses should not allow riders on the bus until departure time to prevent theft and/or vandalism on the bus.
- Always scan the interior of the bus as well as the road ahead for potential hazards.
- **Drunk or disruptive drivers** should be let off the bus at safe, well-lit areas with other people around.



Railroad-highway Stops

- Buses must stop no less than 15 and no more than 50 feet from railroad crossings
- Never change gears when crossing a RR track
- You do not have to stop, but must slow down and check for other vehicles:
 - At streetcar crossings
 - Where police are directing traffic
 - If a traffic signal is green
 - Crossings marked exempt or abandoned
 - Stop at least 50 feet before a drawbridge





Prohibited Practices

- Unless absolutely necessary, avoid fueling your bus with passengers on board. Never refuel in a closed building with riders on board.
- Do not talk with riders, or engage in any other distracted activity, while driving. (This would be impossible for a school bus driver)
- Do not tow or push a bus with riders aboard unless getting off the bus would be unsafe.





- Some buses may have a brake and accelerator interlock system.
- The system will apply the brakes and hold the throttle in idle position when the rear door is open.
- The interlock will release when you close the door.

Do not use this feature in place

of the emergency brake.
