



## OPERATIONAL BLUEPRINT FOR SCHOOL REENTRY 2020-21

Significant efforts were put forth to survey parents on the strengths of Comprehensive Distance Learning (CDL), Hybrid and in-person instruction. Several town halls were held by Superintendent's Office, MLD and SPED. Weekly participation by Beaverton School District (BSD) administrators with the Washington County Public Health on a weekly basis in anticipation of the development of an Operational Blueprint.

Due to the Governor's report released July 17, 2020 and the current levels of COVID cases in Washington County, BSD will start with CDL on September 14, 2020 and is scheduled to continue with CDL through November 14, 2020 at this time.

BSD will provide CDL through virtual learning classrooms supporting interactive lessons in all curricular areas of instruction (K-12). Virtual may be provided by phone, email or zoom per the parent's accessibility and preference. BSD MLD and SPED will utilize McKinley Elementary as an optional site for 1:1 assessment for students. Parents will be provided optional locations throughout the district for assessment locations.

**1c. PHYSICAL DISTANCING**

<input type="checkbox"/> Establish a minimum of 35 square feet per person when determining room capacity. Calculate only with usable classroom space, understanding that desks and room set-up will require use of all space in the calculation. ### 1f. ENTRY AND SCREENING

This can be done visually and/or with confirmation from a parent/caregiver/guardian.
