As soon to be parents expecting our first child, I could see my wife was getting exhausted. She had been in labor for over 24 hours and the baby's vital signs were beginning to register some concerns for the doctor in attendance. The doctor drew me aside and informed me they would soon have to decide about

how best to deliver our child. The delivery team explained the risks of each possible procedure and we made the best choice we could under the circumstances. Our baby came into the world with a team of doctors and nurses converging upon the scene to make sure everything was okay and that no additional procedures would be required. The team administered the APGAR test based on key vital statistics and we were reassured that our child was safe and healthy! As new parents, we had to rely on the team of medical experts to create the best possible conditions for the health and safety of our newborn child.

As we begin the new school year, the Gull Lake team is here to support you and your child with a healthy routine of both academic and social-emotional learning opportunities. Much like the team my wife and I relied on during a challenging delivery, we are here as a team to deliver engaging and inspiring learning experiences to your child as we prepare for our physical return to the classroom at the start of October. As part of our tool kit for support, we will be administering our version of the APGAR test to each student to see where they stand with essential learning and academic progress. Staff will be assessing your child, communicating results and offering supports for you in the home environment so that your child remains on track and confident in their ability to be a successful learner.

We are fortunate to have an experienced team of educators who can deliver real results for kids and families during this time of great change. Along with you, we will partner our efforts to take advantage of new opportunities and innovations that are beginning to take shape. In a school year unlike any other, we would like to thank families for their patience, understanding, and collaborative spirit as we enter new models of teaching and learning. Our district staff has prepared for multiple scenarios with an acute focus on caring for students and building relationships, regardless of the model of instruction. TECHNOLOGY DEPARTMENT DISTRIBUTED DEVICES

This fall the Gull Lake Technology Department distributed over 1,400 devices to families of Young 5 - 8th-graders throughout the district to launch remote learning on August 31st. This number is on top of the nearly 950 Gull Lake High School devices that our students use with their current 1:1 device rich learning environment. Many thanks to all the district staff members that assisted in getting devices out in a timely fashion.

DEVICE SUPPORT HOURS

The district understands that technology at times can break, need a fix, or have general issues, which has the potential to frustrate learners. The Gull Lake Technology Department has established help desk hours to assist students and families in need.

Device support hours are scheduled on Tuesdays and Thursdays from 1:00 - 3:00 p.m. at Gull Lake Middle School Athletic Entrance to drop off devices that need repair. Families can also reach out via email gltechhelp@gulllakecs.org to schedule a time for drop off/pick up outside of the listed hours.

Two 6-year terms will be filled at the November 3, 2020 General Election.

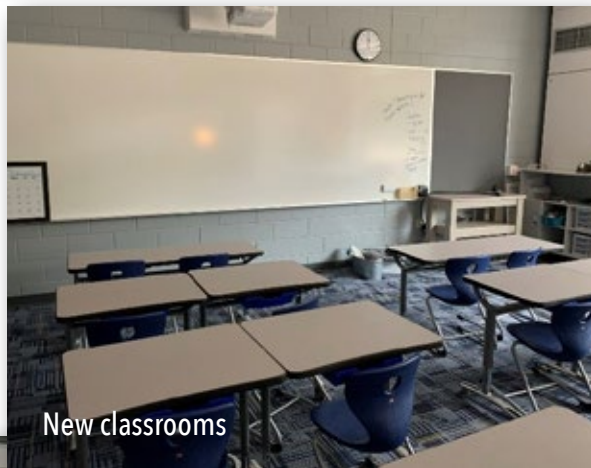
Bond Update

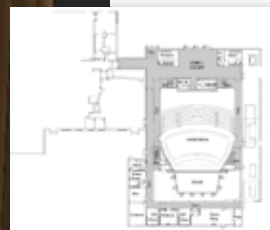


RICHLAND ELEMENTARY

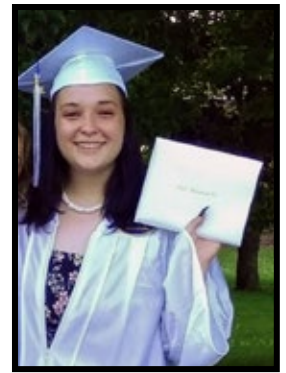

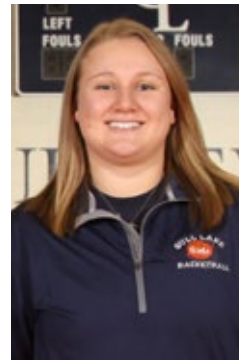

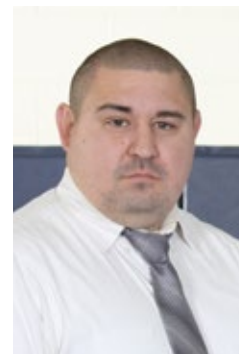


We would like to welcome a few new coaches to the Blue Devil coaching family this year:

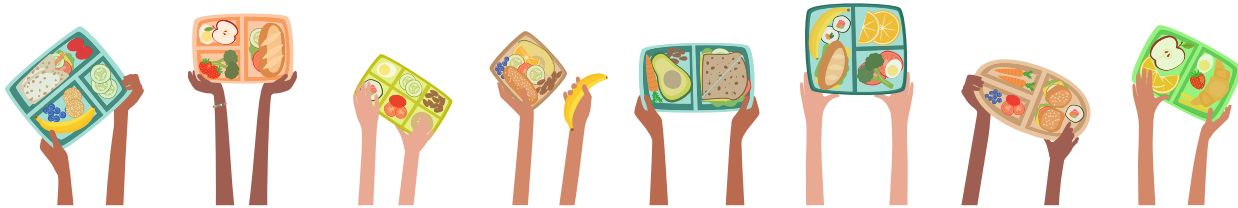
Starting the week of September 7th through December 31st, ALL kids will now eat for free so please come pick up meals on Tuesdays and Fridays!

NOTE: On Jan 1st, 2021 lunch prices will move back to full pay, free, and reduced status.

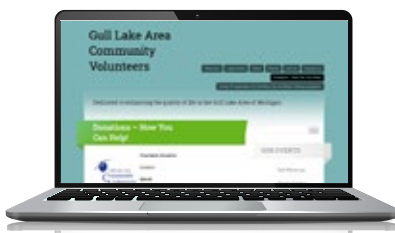


A Note from the Community Volunteers

ACCESS PROCEDURES

Parents of eligible students who wish to review the student's educational records shall request at the attending building. A review shall be scheduled within a reasonable time not to exceed 30 days.

DISCLOSURE TO THIRD PARTIES

Personally identifiable information from the educational record of the student shall not be released without prior consent of the parent or eligible student. Information may be released to certain individuals or agencies as permitted by law.

CONFIDENTIALITY OF EDUCATIONAL RECORDS

The school district has compiled records on all students for use in the provision of appropriate education programs and services. Federal and state legislation provide parents and eligible students (18 years and older) with certain rights regarding the confidentiality of school records.

PARENTAL and STUDENT RIGHTS

Parents of a student or an eligible student have the right to:

1. Inspect and review the educational records of the student.
2. Request information contained in such records be amended if it is inaccurate, misleading, or violates the privacy or other rights of the student.
3. Request a hearing to challenge the content of the student's record.

STUDENT RECORDS consist of:

- a. Personal and family data
- b. Health and immunization records
- c. Test data, including aptitude, interest, intelligence, and achievement testing
- d. Achievement and attendance records
- e. Anecdotal records
- f. Records of conferences
- g. Copies of correspondence concerning student
- h. Student questionnaires
- i. Other records which may contribute to the understanding of the student
- j. Past school records
- k. Individualized Educational Plans for handicapped children

PROCEDURES RELATING TO RETENTION, DESTRUCTION and DISCLOSURE OF RECORDS

Records are maintained at the building in which the student is enrolled or last attended. Each record is kept in an individual file open only to those personnel that have a need to know. Information on grades, attendance, and courses completed are kept forever unless transferred to another school district. Portions of a record may be destroyed when it is no longer appropriate to retain them.

SPECIAL EDUCATION and SECTION 504 NOTIFICATIONS

It is the policy of the District to actively find and provide services to students with disabilities. The District will provide appropriate evaluations, identification and services for full eligible students under Section 504 of the Vocational Rehabilitation Act of 1973 or current Special Education Laws.

CHILD FIND SYSTEM

The individuals with Disabilities Education Act (IDEA) requires all states to have a "comprehensive Child Find system" to assure all children who are in need of early intervention or special education services are located, identified, and referred. Part C of early intervention focuses on children aged birth to three. If you suspect your child has a disability, please contact the District's Special Education Supervisor at 269.548.3400.

ADMINISTRATIVE POLICIES and COMPLAINT PROCEDURES

The District does not discriminate on the basis of disability, sex, age, or race with regard to admission, access to services, treatment, or employment in programs and activities. The District Special Education Supervisor is the coordinator responsible for Section 504, the American Disabilities Act and Special Education. Contact Molly Rabe, at 269.548.3400.

ADMINISTRATIVE POLICIES and COMPLAINT PROCEDURES

The District Policies and Procedures are on file in the Superintendent's Office, as well as on the District web site www.gulllakecs.org where they may be reviewed. contact number is 269.548.3400. You will receive the specific process for the legislation for which you believe is non-compliant.

PEST MANAGEMENT PROGRAM

As part of the Gull Lake Community Schools' Integrated Pest Management Program, pesticides are occasionally used. You have the right to be informed prior to any pesticide application made to the school grounds and buildings. For information on how to be informed of pesticide application dates, contact Brad Glessner, Building & Grounds Supervisor at 269.548.3400.

DRUG PREVENTION

In accordance with federal and state law, the Gull Lake Community Schools Board of Education hereby establishes a "Drug-Free School Zone" that extends 1,000 feet from the boundary of any school property. The Board prohibits the use, possession, concealment, delivery, or property within the Drug-Free School Zone or at any district-related event.

Furthermore, the superintendent shall take the necessary steps to ensure that an individual, eighteen (18) years of age or older, who knowingly delivers or distributes controlled substances on designated and prohibited by Michigan statute with the Drug-Free School Zone to another person is prosecuted to the fullest extent of the law.

WEAPONS-FREE SCHOOL ZONE

Gull Lake Community Schools is a Weapons-Free School Zone. Violators may face expulsion and/or criminal prosecution.

ANTI-BULLYING/ANTI-HARASSMENT

It is the policy of the District to provide a safe educational environment for all students. Bullying, or harassment of a student at school is strictly prohibited. This policy shall be interpreted and enforced to protect all students and to equally prohibit bullying/harassment with regard to its subject matter or motivating animus. The Board also does not limit, segregate, or classify employees in any way that would deprive or tend to deprive them of employment opportunities or otherwise adversely affect the status of an employee as an employee, based on genetic information. Harassment of a person because of his/her genetic information is also prohibited. Likewise, retaliation against an applicant or employee for engaging in protected activity is prohibited.
