



DC Fall Sports Spectator Protocols

General Spectator Guidelines

1. DC will adhere to the guidelines for gatherings issued by the PA Department of Health and will not exceed 250 individuals at a site used for a given contest. Spectator totals will be combined with the overall total of individuals at the game location to ensure compliance (events on multiple, adjacent fields will need to have their totals combined including players, officials and spectators).
2. Spectator areas will be clearly marked and social distancing reminders will be posted in the area.
3. Spectators should arrive no more than 15 minutes prior to the start contest for check-in and will not be allowed on campus before that time.
4. All spectators must wear face coverings unless doing so jeopardizes their health. Those who cannot wear face coverings due to a medical condition must contact the Athletic Office prior to the event so that alternative plans can be made.
5. All spectators must adhere to social distancing requirements of at least 6 feet of spacing for anyone not in the same household.
6. Spectators must not enter the field of play or bench areas.
7. Spectators will need to check-in at designated locations prior to the start of the game they are attending.
 - a. Check-ins may include a temperature check and screening questions.
 - b. Spectators who fail the screening will not be allowed to observe the contest and will be asked to exit the premises.
 - c. Spectators will be provided with a wristband once they have been checked in indicating they have been screened and cleared for the event.
8. Visiting schools will be allocated at least one spectator per player on their team. If additional slots are available at a given event, additional spectators may be allowed to enter.
9. Spectators are not allowed at practices on DC's campus.
10. For **Away Contests**, DCs spectators will need to follow the specific guidelines as provided by those schools. The guidelines will be distributed to the parents via the head coach of that specific DC sports team.

DC Site-Specific Guidelines

1. Upper Campus
 - a. Spectators will need to park on the Bus Loop or Upper Parking Lot.
 - b. Check-in stations will be located at the gated entrance for the Track / Field Hockey field, or at the stairwell headed down toward the turf field
2. Lower Campus
 - a. Spectators will need to park in the Lower Campus parking lot and walk along the pathway behind the school.
 - b. The Check-in Station will be located at the end of the path behind the gym and headed toward the fields.



DC Sport Specific Guidelines

1. US Boys and Girls Soccer (Upper Campus, Turf Field)
 - Spectators will be able to observe games by sitting either on the hill or in the bleacher areas. The bleachers are separated for home and away fans and with distancing can hold approximately 8 spectators on each side. The hill can accommodate more spectators but all must remain physically distanced.
 - Spectators can bring their own chairs to sit on the hill.
 - Wearing face coverings is mandatory.
 - Individuals living in the same household can sit together.
 - Spectators will not be allowed to observe the game from the walkway area as that path must be kept clear.

2. US Field Hockey (Upper Campus, Track Field)
 - Spectators will be able to observe the game from the track section nearest to the DeMoss Center and Lower Gym.
 - Spectators should bring their own chairs as there will be no bleachers or other seating for them to utilize.
 - Wearing face coverings is mandatory.
 - Individuals living in the same household can sit together.
 - Spectators will not be able to observe the games from the walkway areas above the track, nearest to the buildings as we must keep those areas clear.

3. US Football and MS Football (Upper Campus, Bus Loop Field)
 - Spectators should bring their own chairs as there will be no bleachers or chairs for them to utilize.
 - Wearing face coverings is mandatory.
 - Individuals living in the same household can sit together.
 - Spectators must maintain a distance of at least 6 feet from other spectators unless they live in the same household.

4. US Tennis (Delaware County Community College)
 - Spectators may sit on the designated bleacher areas but must wear face coverings and maintain a distancing of at least 6 feet from other spectators.
 - Wearing face coverings is mandatory.
 - Individuals living in the same household can sit together.

5. US Cross Country (Rose Tree Park)
 - Spectators should bring their own chairs if they wish to sit at the start/finish line.
 - Wearing face coverings is mandatory.



- Individuals living in the same household can sit together.
6. MS Field Hockey, Boys and Girls Soccer (Lower Campus Fields)
- Spectators may sit along the sideline opposite from the teams or on the bleachers.
 - Spectators may bring their own chairs to observe games but must maintain a distance of at least 6 feet from other spectators.
 - Individuals living in the same household can sit together.
 - Wearing a face covering is mandatory.
7. MS Cross Country (Lower Campus Course)
- Spectators should bring their own chairs if they wish to sit at the start/finish line.
 - Wearing face coverings is mandatory.
 - Individuals living in the same household can sit together.
