Curbside pick-up times are from 12:00pm-2:30pm Monday (1) Meal, Tuesday (2) Meals and Thursdays (2) Meals. Distribution at West is Door 5 and Central is Main Entrance. Meals will be distributed as follows; Monday (1) Meal - Tuesday (2) Meals - Thursday (2) Meals. Any student up to 18 years of age is eligible for a free meal. Heat all food to a minimum temperature of 165 degrees and hold at a minimum of 140 degrees .
