What I have witnessed over these years is that buying a house in BSD school district has gotten very stressful over the years. This is because there is no stability and predictability to which school your kids will be assigned to. It seems that there is a boundary change process every 2-5 years. People buy houses to be in good school district and some of the schools in the district are better performing than others. Ultimately parents shell top dollar to be in better performing schools only to find some 3 years later that they are going to a different school. This creates a lot of anxiety for parents on 2 levels first for their child's education and second the real estate impact of the BSD's decision to drastically change boundaries. The BSD should be proactively involved in washington county decision to estimate the growth in a particular area and plan accordingly to build new schools in the high growth areas instead of just randomly buying land elsewhere and forcing the stable neighborhoods to different schools. In the long run people will stop buying houses in BSD because of frustration, lack of stability and the stressful boundary change process.
