### One question on the Nov. 3 ballot: Renewal of an existing levy

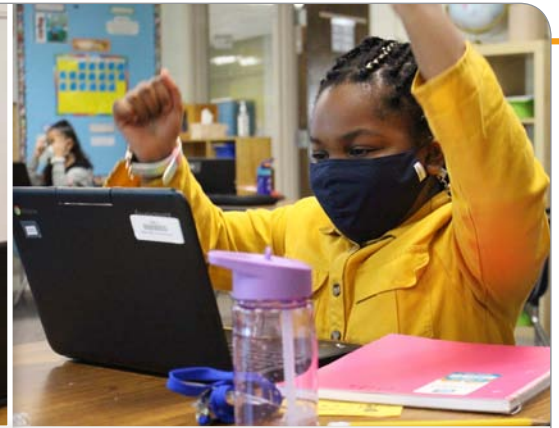
On Tuesday, November 3, 2020, Fridley Public Schools residents will be asked to renew an **existing capital projects levy**. This is a renewal of an existing levy that was last approved by voters in 2011.

Over the past 10 years, funds raised by the capital projects levy have helped support **technology upgrades and deferred maintenance projects** in our schools and district buildings.

The proposed renewal will generate approximately \$1,060,000 a year and will be applicable for 10 years. The money raised through the renewal will be used to cover cost related to:

- ☐ Deferred maintenance and renovation projects at various sites and facilities
- ☐ Technology devices for teaching and learning for students and staff
- ☐ Improved technology infrastructure to support online learning
- ☐ Renovate existing spaces to better meet the educational needs and safety of students.

*This capital projects levy was first approved by Fridley voters in 2002, and renewed in November 2011.*



### PROVIDING ACCESS TO MODERN TECHNOLOGY

*21st century technology to maximize our students' learning capabilities*

The district has relied on this existing capital project levy for the past ten years to provide both students and staff access to modern and updated technology. **Amid the COVID-19 global pandemic, it has never been more clear that the need for modernized technology for all our students is necessary to continue to provide equitable access and rigorous programs.**

As our district transitioned to providing Distance Learning to all students in spring 2020, all Fridley students were issued one device per family. Entering into the 2020-21 school year, it was vital to provide 1:1 Chromebooks to each individual student. Whether learning in school or at home, students rely on updated technology to access instruction and connect with their teachers and peers.

There are over 2,000 devices (desktop computers, laptops, iPads, Chromebooks, etc.) connecting to the district's wireless network every day. As students and staff utilize wireless devices in their classrooms, the demands on the wireless network continue to increase. Wireless access points in each building provides equal access to the wireless network in all classrooms and helps increase personalized learning opportunities for all students.

*Fridley Middle School, which originally served as Fridley High School, was built in 1954. At age 66, it is the district's oldest building.*



### MAINTAINING OUR BUILDINGS & FACILITIES

*Protecting the community's investment in its schools*

**DID YOU KNOW ?** The average age of Fridley Public Schools buildings is nearly 60 years old.

Fridley Middle School (oldest) was built in 1954 and Stevenson Elementary School (newest) was built in 1967. With aging infrastructure, renovations projects are necessary for maintain the upkeep of the buildings and therefore protect the community's investments in its schools.

**The district relies on the capital project levy to help maintain its buildings and continue to ensure that students and staff have the most up-to-date technology for teaching and learning.**

## PROPOSED PROJECTS

### *Maintaining and caring for aging buildings*

The average age of our district buildings is nearly 60 years. The capital project levy provides much-needed funding to allow for the maintenance and care of our aging buildings such as repairing roofs, floors, upgrading and replacing windows and doors with units that provide more security, and upgrading heating and ventilation (HVAC) systems and fire suppression upgrades, as well as addressing modification and installations that enhance the safety and security of our schools and buildings.

If the levy is approved, it will provide much needed funds to address some immediate deferred maintenance projects over the next 10 years.

### **The following proposed projects would be completed during the lifespan of the renewed levy:**

*Funds from the renewal of the capital projects levy will be used to:*

- ☐ Complete deferred maintenance projects at each school and district building
- ☐ Add restrooms to kindergarten classes at both Hayes and Stevenson elementary schools
- ☐ Replace cafeteria flooring at Hayes Elementary School
- ☐ Update science lab casework at Fridley Middle School
- ☐ Replace rooftop HVAC units at Fridley High School
- ☐ Energy efficient window replacement at Fridley Community Center
- ☐ Update classroom casework and interior finishes
- ☐ Update public and student restrooms at Fridley Middle School, Hayes and Stevenson elementary schools
- ☐ Renovate locker rooms at Fridley Middle and High schools
- ☐ Complete reroofing projects at Fridley Middle and Fridley High schools, and Fridley Community Center

### **Upgrading technology infrastructure & devices**



The district has also relied on the capital projects levy for the past 10 years to provide both students and staff access to modern, updated technology. The need for technology is increasing even more now that we are in the midst of many unknowns with the COVID-19 pandemic.

Whether accessing instruction and learning materials in school or at home, our students need up to date technology, and our teachers need technological capacity to provide instruction and connect with students in real time. 1:1 device ration for students will allow students to have a device at home to support a hybrid or distance learning model.

*Should our community approve the renewal of the levy, funds raised by the levy will be used to:*

- ☐ Replace student and staff computers and upgrade technology infrastructure at each school and district buildings.

### School District Question 1

#### Renewal of Expiring Capital Project Levy Authorization

The board of Independent School District No. 14 (Fridley Public Schools) has proposed to renew the school district's existing capital project levy authorization of 5.47% times the net tax capacity of the school district. The money raised by the capital project levy authorization will be used to cover costs related to deferred maintenance and renovation projects at various sites and facilities, technology devices, and technology infrastructure. The proposed capital project levy authorization will raise approximately \$1,016,000 for taxes payable in 2022, the first year it is to be levied, and would be authorized for ten years. The estimated total cost of the projects to be funded over that time period is approximately \$10,160,000. The projects to be funded have received a positive review and comment from the Commissioner of Education. Shall the renewal of the capital project levy authorization proposed by the board of Independent School District No. 14 be approved?

### VOTING EARLY

Particularly this year amid the COVID-19 pandemic, residents may be interested in early voting and casting an absentee ballot. In Minnesota, you can vote early with an absentee ballot starting 46 days before Election Day. To vote early, you must submit a Absentee Ballot Application on the Secretary of State website.

One way to vote early is by receiving a ballot in the mail. You may request an **Absentee Ballot** from the **Minnesota Secretary of State** online, or print an Absentee Ballot Application, and your ballot will be mailed to your home. Included with your ballot is a pre-paid return envelope, which goes directly to the Anoka County Elections Office for counting.

#### VOTE EARLY IN PERSON



Fridley school district residents can vote early with an **Absentee Ballot** at the Fridley Civic Campus, 7071 University Ave NE, Fridley, MN 55432. After submitting an Absentee Ballot Application, you will be given a ballot and be able to cast it in person that day. Early voting began on September 18, 2020 and will continue through November 2, 2020.
