As a military community, Groton schools receive annual Impact Aid grants from the Federal Government, which is a significant portion of our budget and contributes to enriching the educational opportunities of all our students. The amount we receive is based on how many of our school aged population have parents that live or work on federal properties such as the Sub Base. Over 1,700 Groton students are in this category making us eligible to receive a significant amount of funding that will benefit our schools and students.

Please help our community receive this year's funding by completing the attached form and returning it to your child's teacher. The forms are pre-filled with your child's information. Parents/guardians of all school-aged children must complete one form for each child in order for the district to receive funding.

The following instructions will assist you in completing the form. All students are required to have a signed and dated form on file whether they are military dependents or not.

- ➤ Section II Parent/Guardian in Military Service: Please complete this section if either parent/guardian was on Active Duty in any of the Uniformed Services on October 1, 2021.
- > Section III Parent/Guardian in Civilian Employment on Federal Property or Casinos: Please complete if:
  - a) Either parent/guardian was employed on any of the Federal properties or casinos listed in this section <u>on</u> October 1, 2021 as a regular civilian employee (civil service), <u>or</u>
  - b) Either parent/guardian was employed as a private contractor doing work on any of the Federal properties listed in this section.

(ELECTRIC BOAT EMPLOYEES: Please enter the name and number of the commissioned ship you worked on for at least half of the day on October 1, 2021. Please indicate only one (1) ship.)
