Minooka CCSD 201 Return to In-Person Learning

October 13th	All District Staff Return to Schools
October 19th	Hybrid Split Schedule Learning Begins 4 hour In-Person A/B
October 19th	Synchronous Attendance Required for Grades 5-8

Hybrid Split Schedule

Students will be divided into 2 groups for attendance to limit the number of students in the building and classrooms.

Monday and Tuesday: Group 1 (A) In-Person

- Students with last names A-L attend in-person
- Full Remote and Students M-Z attend remotely

Wednesday: Remote for All Deep Cleaning

Thursday and Friday: Group 2 (B) In-Person

- Students with last names M-Z attend in-person
- Full Remote and Students A-L attend remotely

Beginning October 19th, all schools will be open for **four hours** of student contact time and **one hour** of Remote Instruction time.

Special Populations

- Select students may be contacted to begin attending In-Person prior to October 16th to receive services.
- Some select students may be contacted to begin attending In-Person on both A and B student group days

Remote Synchronous Instruction

- It is the expectation that each student will receive a minimum of **3 hours** of synchronous instruction daily with an additional **2 hours** of asynchronous learning (totalling 5 hours of instruction daily).
- At the Junior High, it is the expectation that each student will receive a minimum of **4 hours** of synchronous instruction daily with an additional **1 hour** of asynchronous learning (total of 5 hours of instruction daily).
- A combination of synchronous, asynchronous and simultaneous live-streaming of instruction will begin by October 19th, 2020.
- Attendance will be expected and recorded.
- **Synchronous Attendance Required for Grades 5-8** (Normal Absence Policy Applies)

- Students are required to attend all synchronous lessons throughout a given day. Attendance will be taken at the start of each period. Students not in attendance will be marked absent for the period in which they miss.

Teacher Rosters

- Students will continue with their current teachers as scheduled whether they are In-Person or Remote.
- All teachers will utilize a blended approach in which a portion of the day's instruction will be synchronous and a portion will be asynchronous.
- Increased synchronous (simultaneous) instruction will be gradually implemented and expected for all staff.

- Elementary Schools 8:30 a.m.
- MIS 7:35 a.m.
- MJHS 7:40 a.m.

Fine Arts

- Fine Arts at the Elementary level will be optional and offered remotely to all students with a schedule developed by building administration.
- Fine Arts at the Intermediate levels will be offered in-person with a schedule developed by building administration.
- Students at the Junior High will continue to be provided with access to Fine Arts coursework with a schedule developed by building administration for facilitation of activities. No grades will be given at Elementary, Intermediate, or the Junior High.
