

SMSD Bus Rider Agreement

DUE TO THE THREAT OF COVID-19, ALL STUDENTS ARE REQUIRED TO WEAR A FACE MASK OR COVERING IN ORDER TO BOARD THE BUS.

The school bus service provided by Stafford MSD is freely offered to all Stafford residents. This privilege is intended to be a safe and enjoyable experience for both students and driver. In order to maintain an orderly environment on the school bus, it is essential that students know and understand the rules of riding the school bus and conduct themselves accordingly.

This agreement contains the general rules that SMSD expects all riders to follow when riding the school bus. Parents and students are to review the rules and guidelines outlined below so that both parties know what behavior is acceptable and expected, and the consequences that may result when these expectations are not met.

This will aid bus drivers in maintaining order on the bus and promote a bus-riding experience that is more safe and enjoyable for everyone.

WAITING FOR THE BUS

- Be at your bus stop at least five minutes before your scheduled pick-up time.
- Stand on the sidewalk or back from the roadway while waiting for the bus.
- Stand clear of the bus until it comes to a complete stop and the door opens.
- **DUE TO COVID-19, PLEASE PRACTICE SOCIAL DISTANCING AT YOUR BUS STOP.**

LOADING THE BUS

- Do not run, push, shove, or skip in line when loading the bus.
- For your safety, please use the handrail as you board the bus.
- **All students that are 5th grade and up will need to present their ID badge before boarding the bus.**
- Once you're on the bus, go directly to your assigned seat and be seated.
- Objects too large to be held in the lap or placed under the seat may not be loaded on the bus.

CONDUCT ON THE BUS

- **DUE TO COVID-19, PLEASE PRACTICE SOCIAL DISTANCING BY REMAINING IN YOUR ASSIGNED SEAT.**
- Obey the instructions of the bus driver and be respectful at all times.
- Remain seated, facing forward, with your feet out of the aisle throughout the trip.

- Do not switch seats. (The bus driver is authorized to assign seats.)
- Talk at a level that is not overly loud or distracting.
- Do not stick your head, hands, or any other body part out of the window.
- Keep your hands and feet to yourself at all times. No horseplay or fighting allowed.
- Do not use obscene, vulgar, or offensive language or gestures towards anyone.
- Do not throw objects inside the bus or out of the windows.
- No eating or drinking allowed on the bus.
- Do not litter, vandalize (mark, cut), or damage any part of the bus.
- The use of cell phones or any device capable of capturing images is strictly prohibited on the bus.

EXITING THE BUS

- Stay seated until the bus is completely stopped at your designated stop.
- Use the handrail and take one step at a time when exiting the bus.
- Exit the bus in an orderly fashion as instructed by the driver.

PARENT PICK-UP (ECC/ELEM)

- A parent/guardian must be present at the bus stop in order to receive students from PK-2nd grade.
- Younger students may be released with siblings that are in the 3rd grade or higher.
- If a responsible person is not at the bus stop, the young student will be returned to their campus.
- **After a student is returned to campus 3 times, they will forfeit their bus riding privileges home for the remainder of the semester.**

PROHIBITED ITEMS

- Tobacco, cigarettes.
- Alcoholic beverages, illegal drugs, or chemicals.
- Glass containers.
- Live animals or insects.
- Weapons and explosive devices.
- Matches or cigarette lighters.

DISCIPLINE

The school bus is an extension of the classroom and discipline will be administrated by school principals and assistant principals. The bus drivers will attempt to address student misconduct, however, if the misconduct persists, a referral notice will be submitted to the respective campus of the offending student. After the initial verbal warning is issued by the driver, the campus will assess discipline as follows:

- 1st Referral: Warning
- 2nd Referral: Parent conference**
- 3rd Referral: 5 days bus suspension
- 4th Referral: 10 days bus suspension
- 5th Referral: 20 days bus suspension
- 6th Referral: Suspended for Semester

** (3-day suspension if unable to setup conference)

In case of serious misconduct that endangers the safety of other passengers and/or the driver, the student(s) will be removed from the bus by a school official or law enforcement officer. The principal and parents will be notified of the situation as quickly as possible.

Please note: Serious offenses- such as fighting, possession of weapons, drugs, or other controlled substances, and making harmful threats to the bus driver or students, may result in the bus rider being immediately suspended from the bus.
