Time for lunch at home and transition to school building will take place from 10:30 AM - 11:30 AM

Group A students will learn in-person from 11:40 AM - 2:20 PM on Mondays and Wednesdays

Group B students will learn in-person from 11:40 AM - 2:20 PM on Tuesdays and Thursdays

On afternoons that students do not attend in-person, they will be engaged in asynchronous learning activities

On Fridays, all students will receive virtual synchronous instruction in the morning and asynchronous instruction in the afternoon

Students will have a traditional school
calendar and daily class schedule
provided by the teacher

Students will be assigned to a new
teacher who will provide instruction
and activities aligned to the
core SD129 curriculum

Opportunities to participate in
extracurriculars such as before/after
school athletics, fine arts,
and clubs for all students

A mode of instruction that will
not be impacted by future, more
restrictive state mandates
related to COVID-19
