# Special BOT Meeting Minutes Monday, August 14, 2020 Maine School of Science and Mathematics VIRTUAL

I. The meeting was called to order at 8:00am by D. Ferguson, Chair, followed by introductions.

D. Ferguson gave background information regarding the reason for holding this meeting. He explained that the Title IX law changed effective today (8/14/2020). Per legal counsel, MSSM needed to be in compliance with these new laws. All policies affected have been reviewed by Sarah Forrester. This meeting is the first step in the process and by no means the last time we will talk about these Title IX policies. The draft policies are based on Maine School Management Association (MSMA) policies and updated based on MSSM's uniqueness; which included minor changes such as Executive Director in lieu of Principal, etc.
