Mrs. Melnick announced that the New Teacher Reception with the Board of Education will be held on September 3, 2020 at 6:00 p.m.

# <u>Staff</u>

Dr. Fournier and Dr. Arakelian updated on the District's Reopening Plan. Dr. Fournier stated that there are twenty-six new employees, fourteen of which were hired for COVID-19 staffing. Dr. Arakelian presented general highlights on safety protocols. The staff received training on COVID-19 protocols as well as Emergency Preparedness Training. In-person training will be conducted at the Kindergarten (Leisure) Center. The Health/Life Safety was completed at the Kindergarten (Leisure) Center, by Margo Fennelly of the Regional Office of Education.

Dr. Fournier introduced Trevor Hope, Director of Technology, and Tarah O'Connell, Director of Communications. Dr. Fournier stated that the Opening In-Service was held. New Teacher Academy was held on August 12<sup>th</sup> and 13<sup>th</sup> with the new teachers and their mentors. The themes were social-emotional support, curriculum meetings, technology and the synchronous tools. She added that 83% of students are in-person, and 17% are learning remotely. At K-2 we are at 18-20 students per classroom including remote learners, and at Shabonee we are at 18-23 per classroom including remote learners. There are currently 133 students enrolled in kindergarten.

Dr. Fournier reported that we had a FOIA Request from SmartProcure requesting our vendor information and the request was replied to in the appropriate amount of time.
