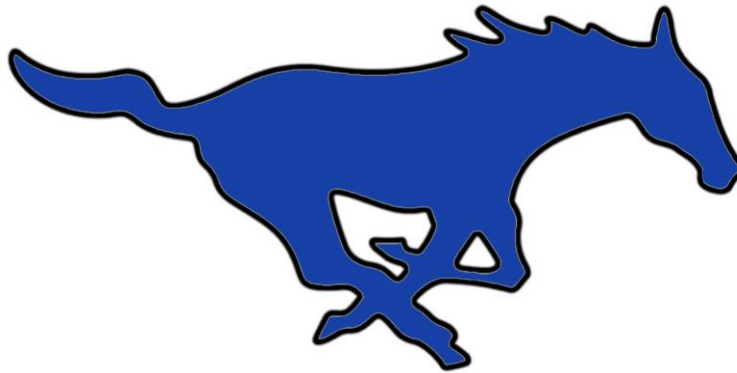


# Friends of Friendswood ISD

## **Friends of Friendswood ISD Guidelines**

- The discount or service offered must be **EXCLUSIVE** to Friendswood ISD employees (offers that are not available to the general public).
- Only one Independent Consultant can be featured from any company. This will be on a first-come first-served basis.
- Agreements must be signed each school year to continue the advertisement on our district website. The discounts offered will be good for that school year and updated each year.
- Businesses need to be able to accept the employee's district nametag as proof of employment since not all our employees have photo badges.
- We will only offer online advertising to the business that is offering the employee discount.

This Agreement is made and entered into as of \_\_\_\_\_ (hereinafter referred to as the "Effective Date"), by and between the Friendswood Independent School District (hereinafter referred to as "FISD"), at 302 Laurel, Friendswood, Texas 77546, and \_\_\_\_\_ (hereinafter referred to as "SPONSOR") at \_\_\_\_\_ (ADDRESS).

WHEREAS, FISD has the exclusive right to market, sell, and control all advertising displayed on the District Website per Board Policy GKB LEGAL and GKB LOCAL.

WHEREAS, SPONSOR desires to acquire from FISD the right to display certain advertising and to conduct or participate in certain promotions on the District Website for the joint purpose of providing discounted or specialized services to District employees and advertising of the SPONSOR'S products or services;

NOW THEREFORE, in consideration of the foregoing, incorporated herein by reference as provisions of this Agreement, the mutual promises set out below, and other good and valuable consideration, the parties agree as follows:

1. The DISTRICT will identify the SPONSOR as a Friend of FISD on District Website and in future District publications related to this program.
2. The DISTRICT will provide a link to the Sponsor's webpage on the Friends of FISD Home Page.
3. The SPONSOR will provide some type of discounted or special service to employees of FISD upon verification of employment status in a manner defined by the SPONSOR. (Please attach a PDF document of this discount or special service to this agreement with details and steps to take for employees to request said discount, incentive, or special service at SPONSOR's location). The discounted or special service would be an offer that is exclusive (not generic) offer for Friendswood ISD employees.

Term of Agreement: The term of this Agreement will be for one school year.
