Please Note:

The following criteria will be used to determine the eligibility of a member to receive donations and to determine the number of days to be donated:

1. A teacher must have a catastrophic illness or injury or combination thereof and must provide timely and competent medical certification of the catastrophic illness or injury or combination thereof.
2. A teacher must have exhausted all accumulated sick leave.
3. A teacher shall not be entitled to any other paid leave, remuneration from disability payments, workers' compensation, and/or other such benefits.

If the Superintendent and the Association representative have agreed to activate the sick leave bank, donations will be accepted by the Board on a first come, first serve basis until the number of days donated to the eligible member totals sixty (60) days.

Teachers who donate paid days to the eligible member shall have the days deducted from their total accumulated sick leave.

Once donations have been accepted, the Superintendent and the Association representative may issue a grant of days from the Sick Leave Bank of no more than sixty (60) days to any individual teacher.

The aggregate number of days donated in any school year shall be a maximum of one hundred eighty (180) days.
