Dr. Pomponio thanked the teachers, staff and administration for their diligent work to get students' schedules out and all the work put into getting almost 3400 students in classes both online, atlas and working with the early middle college classes. This was not a small task, there was a lot of work put into it. She appreciates all of them. She is also thankful for Candace Duane, Karen Dunholter, Alyssa Brandt from Fordline and Deb Theisen from technology and all those that worked on the project for the new page just added to the Southgate district website called Student Family and Wellness. The page includes everything one may need for district social workers; referral forms, social work newsletters, community resources and so much more. Especially and most important on the link is the

Teen Wellness website, there is a section on self-care. This information is special to her; she has worked with staff on several committees including suicide prevention committee of which they wanted to get a wide range of resources like this added for parents and students. She is happy to see this new resource come to fruition and it is awesome.

Dr. Pomponio commented that decisions made by the board are never taken lightly and are thoughtfully considered from all perspectives. They will continue to monitor data virus peaks in the state as well as colleges and school throughout Michigan. We are looking forward to going back to normal with at least lowered risks. There's a lot of work put into ensuring students are getting all of the material that they need, whether they were face-to-face or online. It's a new time, we will get through this and hopefully get back to face-to-face soon, but he wanted to thank everybody. He backed Dr. Pomponio on her statement.

Mr. Estheimer thanked the staff and welcomed our students. It's a different way this year, but whether you are virtual or face-to-face, teachers are still happy to see students smiling faces. He gave a special shout out to some of those teachers on social media that on their own time are responding and replying to individual comments and questions and putting out small fires. That means a lot to the parents. Several parents have reached out to him thanking him for those individuals that have helped them along the way, after hours, even in the middle of the night.
