Hakoobowka

1. Shariga Utah may an ogolaathey ka dala'awka qidmooyinka fasaloo todoba illaa tuma ii lama. Tan may luku wathey inii kutaabkaa luku fathaw qidmooyinka qoraalatha iskoolka, saadadka, hooloo, ii barnaamijyatha.
2. Qidmooyinka kulushoo may quseeyaana ku reebowka.
3. Kutaabta oo dhan oo lan diithi odsiyaalka ku reebowka qidmatha may leeyiina haquuqta ra'faanka.

Heerka Ku reebowka Qidmatha Degmaatha

Nidaamka Ku reebowka Qidmatha

Maamulaaga iskool kasta may lan hil saarey sithii qof fiiriyaw oo go'aan ka deeraw odsiyatha ku reebowka qidmatha. Degmatha may ku gohona inii hubiitha in nithaamka laka helaw ku reebowka qidmaatha lan maamula si adaalad eh, sitha ujeedka eh, iyee oo an jarna daahaw. Sithoo kala, degmaatha may suubiyaasee hubaalka inii nithaamka ku fogaathaw dhalee'atha, eebta, feejignaanta aathiga aan hayna, ii uleys ma'quul aan hayna oo kutaabta ii waalidka. Nithaamka ma weel dhathaw tilmaamayaal lan aragaana oo an hogaamiyaw qof kasta si an aqoonsatha odsathayaalka ku reebowka qidmatha, oo an jarna kutaabta degmatha (anku hayna kutaabta reeroshoo/waalidka odsathooyo) may lan ogolyaa inii ka kaalmoyto nithaamka odsathaga. Aqbaarta ku kooyaasa reeroo/waalidka may laka haayee qarsoodiga anka toosan intii laka jara nithaamka oo dhan.

Sithoo kala, walaalow ogaw inii kutaabka helooya ku reebowka qidmaatha mal anla dhaqamaw si ka duwan kutaabta kala, ii may lan aqoonsathey sithii kutaabka ka jara ku reebowka qidmaatha oo kutaabta kala, hubnaha shaqaalaga, ama dadka kala anKa baahanayna ogaanshaga inii aqbaarta.

An qalamowka Ku reebowka Qidmaatha

Kutaabka may an qalamey ku reebowka qidmaatha hattii:

1. kutaabka an qalama qatha bilaash eh sitha waafaqsan heerarka USDA
2. kutaabta may heley SSI
3. reerka kutaabka may heley TANF
4. kutbaata may ka jaraana daryeelka koriska, ama

5. kutaabta may ka jaraana haayowka degmatha

Intaas may dheera, hattii atha qobto gurmada dhaqaalaga oo sababeen qasaaraga shaqada, jirooyinka wiin, ama qasaaraga kala ee wal ku oolka daqliga dhaafsan hakameeyowka, onogaa may anqalama koree ku reebowka qidmatha hittaa hattii sharuuda an qalamowka kala lan buyna. Hittaa hattii kutaab anka qalana heerarkun, iskoolka waa inii wili biyaa ku reebowka qidmaatha hattii ku dala'awka qidmaatha diithaw kutaabka fursata si buyta lan ku qiibgalaw ama lan dhammaasiraw sharuuda sababtoo eh awoodla'aanta laka biyaw qidmaatha.

Si kastaba, si markaas lanka qalama ku reebowka qidmatha, iskoolka waa inii helaa WARAAQAGA laga adeeyaw an qalamowka kutaabta. Waa inii dhammaasirtaa Odsaga Ku reebowka Qidmatha ka haboon oo an gudbi maamulaaga iskoolka oo fiiriyowshoo ii ansihinta. Sitha an ka dhaqsi bathan oo ha dirta foomamka dhammaasiran, sharuudoo qidmaatha may quseeyaayaana illaa go'aanka anka dambeeya la suubiya oo ka saabsan an Qalamowka kutaabka oo ku dhaafowka qidmaatha. Hattii odsaga la diitha, iskoolka may hakin direy Foomka Go'aanka ii Ra'faanka. Foomka may kiin sheegey sababta odsaga lan diithi oo fafaahi sithii lan ku ra'faan qaathathaw go'aanka. Hattii atha ku ra'faan qaathata diidmatha ku reebowka qidmaatha, man baahaniithi inii isku biitha qidmaatha illaa ra'faanka la go'aansatha.

Hattii kutaabtaa an qalama ku reebowka qidmaatha, qidmooyinka kulushoo may buwaa inii luku reeba, oo ka jaraan – laakin maku hadithan – haan higaan:

Qidmooyinka diiwaangeliyowka, qoraalatha buugta, buug-qoraalka ii qalabka dabaajiyatha, saadadka iskoolka, kaararka hoola, hooloo ta'liinta dhaafsan, ii qufalatha iskoolka; qidmooyinka sheybaarka ii dukaamatha; qidmooyinka jiimka ii shukumaanka; qarashaadka oo labiska iyo isbeeratha; safaroo dalhiiska ii qidmooyinka usu kooyowka; qarashaadka safaroo fasalka ii koohta; ii qarashaadka qalabyatha muusikatha oo laka isti'maalaw fasaloo iskoolka ama hooloo.

Ma jaraan walyaala saas amal eh sithii qima “lanku reeba korno” ama “iqtiyaar eh”, laakin badelatha ku reebowka qidmaatha may laka diyaariyi koree haalathoo qaarshoo, laakin ma eh qidmooyinka buugga qoraalka. Iskoolka maka warsatha koro inii suubithi beesa biyow kiskistoo eh, IOUs, ama qorshooyinka beesa biyowka daayi.

Qarashaadka faraantiyada fasaloo, kutaabta sannadka, sawiryaalka iskoolka, jaakathoo warqada, ii sheeyoo la midka eh ma eh qidmooyinka oo may an baahanyiin inii lanku reebna. Saas oo kala, hattii kutaabkaa lumiya ama an wal yeela dhismooyinka iskoolka si ka haboon, qarashooyinka badelka ama suubiyowka ma eh qidmooyinka oo may an baahantaa inii luku reeba. Kutaabta ay an baahatha kortee inii biitha qidmooyinka oo diiwaangeliyowka isku midka eh ama koorsooyinka meeleynta hormarsan. Qiibta qidmooyinka la hiriirta gaar haan kuleejka ama buundooyinka iskoolka sara dhaafsan ama buundatha ma quseyta ku reebowka qidmaatha. Intaas may dheera, bas eh kutaabtaas oo biyeen buugga qoraalka aMA dabaajiga qalabka an qalama inii helaan beesa nagowka dabaajig oo dhammaadka sannadka.

Iskoolka ii shaqaalaga iskoolka ma reeba koraan, yareeya koraan, ama ma hoojiya koraan fasaloo ama buundooyinka, ama ma la hera koraan fasaloo, buundada, kaararka wargeliyowka, qoraalka, ama dibloomooyinka si lan hoojiya beesa biyowka qidmooyinka. Iskoolka may reebada koree diiwaanada

kutaabka rasmiga eh oo masuuliyada kutaabka oo hantitha lunti ama wal yeelanti oo iskoolka isku leh; si kastaba, ma reebatha koro diiwaanka kutaabta oo ku roojiyaasa kutaabka ku qiibgalowka iskoolka ama si ka haboon lan ka meeleyl iskoolka.
