1.			I/We understand that the iPad/device and its accessory equipment are the property of the Lamoille Union District 18.
2.			I/We understand that the student, with support of parent/guardian, is responsible for the daily care and maintenance of the iPad.
3.			I/We understand and agree to follow the rules and regulations of Lamoille Union's Acceptable Use Policy and iPad Code of Conduct and iPad Policy and Procedures. Failure to follow the Acceptable Use policy will result in disciplinary action. See http://lancerone.wix.com/lancer1 for details.
4.			I/We understand that the iPad/device will be returned at the school's discretion for maintenance, upgrades, and violations of the Code of Conduct.
5.			I/We understand that I/We must report all iPad damages or the theft/loss of the iPad/device to the building administration within one school day. In the event the iPad is stolen, a police report must be filed.
6.			I/We understand that Lamoille Union is not responsible for any damage experienced, including, but not limited to, loss of data or interruptions of service. The district is not responsible for the accuracy or quality of information obtained through or stored on the electronic resources system including the Internet, or for financial obligations arising through their unauthorized use.
7.			I/we understand that Lamoille Union has secured insurance for all student iPads. If an iPad is damaged, parents/student are responsible for \$50 per event, up to a maximum of two events. Any additional incidents may result in full replacement cost of the iPad. In the event that an iPad is lost or stolen, or if the iPad is damaged beyond repair, a \$500 fee will be assessed to replace the iPad. If an iPad is found in an unsecured area, it will be taken to the Helpdesk.
8.			I/we understand that the school may install apps or programs on the iPad/device to comply with the Lamoille Union Acceptable Use Policy as well as state and federal regulations.

9.		<p>I/we understand that students or parents may wish to carry their own personal insurance to protect the iPad/device in the event of theft, loss, or accidental damage.
