**PAYMENT OPTION (SELECT ONE):** All payments will be made using the FACTS tuition management system. A \$45 annual administrative fee will be charged by FACTS for all payment options. Payments made with a credit card will be charged a processing fee each time a payment is made as determined by FACTS. All families must have a valid FACTS payment account at all times. Once your weeks have been selected, the full amount will be applied to your FACTs account. You will receive an email from FACTs once the charges have been posted. Please review your account to ensure the charges are correct. We will not issue credit if your child(ren) does not attend all weeks selected, for any reason, unless we have to make an institutional decision to close our camp.

- Full payment due to the office no later than June 12th, or drafted through FACTS on June 15th
- 2 equal payments (June – July) deducted through FACTS on the 15th of the month
- 4 equal payments (June – July) deducted through FACTS on the 15<sup>th</sup> and last business day of each month

**TUITION POLICY INFORMATION:** The financially responsible party signing this form understands and agrees to follow the *Tuition Payment and Fees Policy* and the *Delinquent Payment Policy* posted on the St. Gabriel Preschool website.
