## Getting Comfortable with the *Crier*

## Different Year, Different Procedures, Same Exposure to College Representatives

This year, we will offer online visits from college representatives to the **senior class only**. Unlike previous years where students had the option of asking permission to leave class or using their study halls to visit with reps, all of our visits will be online in the late afternoon and early evening hours on Tuesdays and Wednesdays. Because of our new schedule and limited time, not all universities and colleges will be able to visit. If a school from a seniors’ list is not visiting, we encourage students to take advantage of online information sessions and direct connection through the college or university.

Seniors will receive an email from Ms. McKay on Monday evening and Tuesday evening, notifying them of our Tuesday and Wednesday visitors; these emails will include the presentation link. Ms. McKay’s email will highlight which of these require pre-registration.

The list of visitors will also be posted on Naviance; as long as colleges are included on students’ “Colleges I’m thinking about” or “Colleges I’m applying to” lists, students will get an email notifying them of the upcoming visit. The visits are for senior students only; we ask that no parents or guardians join in on these conversations. A college counselor will always be present to moderate.



## AP Exams: What to Know

Any student in an Advanced Placement (AP) course should follow their teachers’ registration instructions and use the appropriate join codes. Payment for the exams will be due by mid-November. A payment link will be shared soon. The AP Exam Policy is listed below:



Ninth through eleventh graders are **required** to take all of their AP exams. Seniors are **expected** to take all of their exams; however, if seniors change their mind between October and April and decide not to take an AP exam, they are entitled to a full refund of the \$95-per test fee. **\*\*This is not typical, but is a concession being made by the College Board given the challenges of last Spring’s online exams\*\*.** In lieu of the AP Exam, seniors are **required** to either take a graded **final exam** or complete a substantive **project** determined by their AP teacher. Appropriate advanced notice must be given to the AP teacher and the AP Coordinator, Lynn Kittel.

## PSAT Update and Opportunity

Due to health and safety concerns, Bullis will not be administering the PSAT on Wednesday, October 14<sup>th</sup>, as we originally planned. The College Board has offered an alternative date of Tuesday, January 26<sup>th</sup>, and we are exploring that option. The College Board has stated that the January date will also serve as an official qualifying exam for National Merit consideration for juniors.

As an alternate option this fall, we are supporting a program offered by [Applerouth, Inc.](#), a national test prep company. Bullis has a longstanding positive relationship with Applerouth, and we are pleased to promote this free standardized test preparation and full-length practice exam. 
