#### GOALS

## UNDERSTANDING COVID-19

**GOAL:** SFASD will prioritize the physical and emotional health of more than 8,000 students, 1,100 employees, 5,400 families, and 50,000 residents over all other concerns.

### **UNDERSTANDING COVID-19:** *TERMS AND DEFINITIONS*

- **Asymptomatic:** when an individual is a carrier of an illness but does not show symptoms.
- Close Contact: any individual within 6 feet of an infected person for at least 15 minutes with or without a mask
- **Contact Tracing:** An attempt by public health officials to identify situations in which an infected person is transmitting the coronavirus, and then warn others who may have been exposed through that person.
- **Confirmed Case:** Someone tested and confirmed to have COVID-19.
- **Isolation:** separates sick people with a contagious disease from people who are <u>not</u> sick.
- **PPE:** PPE Stands for **P**ersonal **P**rotective **E**quipment. This includes masks, face shields, gloves, gowns and other coverings used to prevent the spread of infection to themselves and others.
- **Quarantine:** quarantines keep people away from each other to prevent the spread of disease.
- Self Quarantine: choosing to separate yourself when you're sick from healthy individuals to prevent spreading illness.
- **Social Distancing:** putting space between yourself and other people. Ideal Social Distancing is 6'.
- Symptomatic: When a person shows signs of illness. For COVID-19, that includes cough, fever, loss of taste/smell, or shortness of breath.
- In Person: Students and employees return to full day, in person school.
- Virtual Instruction: Instruction that is taking place from home/outside of the school building.
- Livestream: Students access synchronous instruction from home by listening to and watching their classroom.
- **Cyber: c**yber learning offers individualized instruction and flexibility so that students and families can find a schedule that works best for them.

## RETURN TO IN PERSON LEARNING: GRADES K-6

**GOAL:** SFASD will use the guidance of the state and federal government as well as support from the Montgomery County Office of Public Health in planning to reopen schools in person.

## IN PERSON LEARNING: MASKS



- Masks: students and employees will wear mask at all times, except during lunch and during mask breaks. Masks will be worn:
  - On the bus
    - In the classroom
    - In the hallways
    - In the bathroom and locker rooms
- Mask Breaks: to the extent feasible, mask breaks will be provided when students can maintain a minimum of 6' social distancing.
- What type of mask is allowed? According to PDE, "face covering" means a covering of the nose and mouth that is secured to the head with ties, straps, or loops over the ears or is wrapped around the lower face. A "face covering" can be made of a variety of synthetic or natural fabrics and can *include* a plastic face shield that covers the nose and mouth. "Face coverings" may be factory-made or sewn by hand. While procedural and surgical masks intended for health care providers and first responders, such as N95 respirators, would meet these requirements, these specialized masks should be reserved for appropriate occupational and health care settings.
- How will mask wearing be enforced? Students will be offered a mask if they do not have one. If they fail or refuse to wear a mask, they will be sent home.
- What if a student forgets a mask? Students are expected to attend school wearing a mask when they are dropped off or when they load a bus. If a student forgets a mask one will be provided.
- Are there exemptions? Students that have a medical exemption must go through an Individualized Health Plan or 504 Service Agreement process or have a documented disability that precludes them from wearing a mask.

### IN PERSON LEARNING: CLASSROOMS



- How far apart are desks? Students will be distanced to the extent feasible. We will not be able to maintain a 6' space between students throughout the school day. This will largely be determined by the number of students in each class/room. All desks will face the same direction.
- How many students per class? K-4 classrooms are capped at 24 students; grades 5 and 6 will be capped at 30 students




## IN PERSON LEARNING: CAFETERIA



- How will students eat lunch? Grab and Go bagged lunch will be offered to students. Depending on the school:
  - Students will eat at desks placed 6' apart
  - OR students will eat at opposite ends of 6' tables.

### IN PERSON LEARNING: RECESS, BREAKS, AND CLASS CHANGES



- Will recess take place? Yes, recess will still take place. Outdoor recess will take place whenever possible. Students who participate in outside recess are not required to wear face coverings as long as the 6' social distancing guideline is followed. If students are within 6' of each other wearing a face covering becomes necessary, even outdoors. If outdoor recess is not possible, recess will take place in the classroom. Students and employees will be required to wear masks during indoor recess. To maintain Contact Tracing, students in 5th and 6th grade will not have outdoor recess.
  - Recess and Play Best Practices: students will wash hands or use sanitation stations before and after recess and any time equipment is shared. Equipment (toys, balls, hoola hoops, etc.) will be cleaned daily, but may not be cleaned between each use.
  - Will students receive "mask breaks?" Yes, scheduled mask breaks will be built into the day. Mask breaks will take place when students are at least 6' apart to last no longer than 10 minutes.
    - Elementary Example: classrooms may have a designated mask break area for students to take individual breaks as needed.
- How many kids will be in the hallway at once? Transitions will occur normally, and masks will be worn at all times. Students in grades K-6 travel with classes and will coordinate around other classes.
   Where passible, and way bellways may be capsidered.
- Where possible, one-way hallways *may* be considered.
  - K-4 Class Changes
    - Specials (Phys Ed, Art, Ram QUEST, etc.) will take place in the homeroom eliminating the need to move throughout the building.
    - All students with special needs will change as needed
  - Grades 5 and 6 Class Changes
    - 5 and 6 switch teachers will change their rooms, students will not change
    - Specials (Phys Ed, Art, Ram QUEST, etc.) will take place in their assigned rooms. These limited class changes will be coordinated at the building level.
    - All students with special needs will change as needed

### IN PERSON LEARNING: BUSSES

- How will children social distance on a bus? Students will not be socially distanced on school district conveyance. Drivers and students will wear face coverings at all times when on the bus. To maintain contact tracing, all students will have assigned seats.
- Does the transportation survey completed this summer still stand? No. Transportation will run normal routes regardless of the number of students utilizing district-provided transportation.
  - How will busses be cleaned between runs?
    - Busses will be wiped down between each run
    - Deep cleaning will be conducted mid-day
    - Busses will be wiped down again each evening allowing chemicals time to "sit" overnight
  - Will fresh air circulate during the bus ride?
    - Yes, windows will remain open or "cracked" throughout the ride.

## SCHOOL BUS SEATING: NO MORE THAN 3 TO A SEAT



### IN PERSON LEARNING: DAILY CLEANING

#### SFASD will utilize EPA approved disinfectants against COVID-19.

- All frequently touched surfaces will be cleaned, sanitized & disinfected at least 1x/day 5 days per week per CDC Guidance.
- All classrooms will be cleaned, sanitized & disinfected at least 1x/day 5 days per week per CDC Guidance.
- All bathrooms and locker rooms will be cleaned, sanitized & disinfected at least 1x/day 5 days per week per CDC Guidance.
- Day custodians will sanitize high touch areas at least once a school day.
- Disinfecting wipes will be provided to all occupied areas in each building.
- Hand sanitizing stations will be installed in every classroom, building primary entrances and office areas.
- All drinking fountains will shut off. Bottle fillers will be in use where available. Students are encouraged to bring refillable water bottles.
- HVAC operation will follow ASHRAE Reopening of Schools recommendations 2020 where attainable
- SFASD has increased the hours of our custodial staff
- Classrooms: All desk surfaces are cleaned and disinfected; all sinks, water filling stations, and counters are cleaned and disinfected; door handles and light switches are cleaned and disinfected; trash cans are emptied and spray with disinfectant; and lightly sprayed a mist of disinfectant through the room when leaving
- Bathrooms/Locker Rooms: Clean toilets and urinals with disinfectant; clean and disinfect bathroom floors; spray toilets and sinks with disinfecting mist and allow to dry; and clean and disinfect bathroom door handles
- Hallways and Stairwells: Clean and disinfect handrails; clean and disinfect door handles; and clean and disinfect water fountains
- Cafeteria: Clean all floors with disinfectant floor cleaner; clean and disinfect door handles. Tables and chairs will be wiped down between lunches.
- Day custodians will sanitize high touch areas at least once a school day.
- In addition, our school community is reminded to promote universal precautions among students, including frequent hand washing.



### **IN PERSON LEARNING**: PARENT EXPECTATIONS

All parents must review the following checklist prior to departing for a district building each morning. If <u>ONE</u> of the following symptoms are detected, the parent should not send their child to school:

- Fever of 100.4 or higher
- Cough
- Shortness of breath
- Difficult breathing
- New loss of taste or smell

All parents must review the following checklist prior to departing for a district building each morning. If <u>TWO</u> of the following symptoms are detected, the parent should not send their child to school:

- Chills
- Fatigue
- Myalgia
- Headache
- Sore throat
- Congestion
- Nausea
- Vomiting
- Diarrhea

Employees will follow the same daily checklist as parents and will continue to complete required daily Return to Work forms.



### **LEARNING WHILE QUARANTINED**

#### How will students continue learning while quarantined?

- Quarantined and Ill: if a student is out of school with any illness COVID, standard flu, sinus infections, etc. their parent/guardian should call the school's Attendance Line to report their student absent. As with any other year, they will be expected to make up work and should do so by working directly with their teacher.
- Quarantined/Self Quarantined and Not Ill: if a student is quarantined or self quarantined, but the student is not ill, they should complete their school work from home
  - Secondary students will continue to follow online through Canvas
  - Elementary students can be assigned to a virtual classroom until they return to school




It is recommended that your family quarantines for 14 days upon return.

If you have any questions or are unsure if your child should be in school, please don't hesitate to call your school's nurse. QUARANTINED AND ILL: if a student is out of school with any illness – COVID, standard flu, sinus infections, etc. – their parent/guardian should call the school's Attendance Line to report their student absent.

QUARANTINED/SELF QUARANTINED AND NOT ILL: if a student is guarantined or self guarantined, but the student is not ill, they should complete their school work from home

### **UNDERSTANDING COVID-19:** SPRING-FORD TASK FORCE

Task Force members were trained by Michel Masters, Montgomery County Office of Public Health Division Director of Communicable Diseases Control and Prevention Department.

#### SFASD COVID liaison

- Notifies the Montgomery County Office of Public Health of positive student or employee case during the school day
- Isolates positive case
- Gathers information on close contacts in school/bus for OPH
- Track isolation and quarantine periods for cases and close contacts

#### Montgomery County Office of Public Health

- Determines infectious period of positive case and close contacts
- Determines end date for all isolations/quarantines
- Works with positive case to contact trace outside of school community



#### What happens when SFASD learns of a confirmed case (timeline)

- Task Force will obtain as much of the following information as possible:
  - Person's name and phone number
  - Last date person attended Spring-Ford class or activity
  - Their building/teacher(s)/bus number/activity or team(s)
  - Known close contacts at Spring-Ford

This information will be reported to:

- **Elementary:** COVID Liaison, Erin Lewandoski OR
- **Secondary**: COVID Liaison, Jaclyn Gospodarek
- **Extracurricular:** Mickey McDaniel

COVID liaisons will follow up with the Montgomery County Office of Public Health or the Chester County Health Department.

### IN PERSON LEARNING: ASSESSING AN ILLNESS IN SCHOOL

Spring-Ford's School Nurses will refer to the COVID-19 School Exclusion Recommendation chart when determining if/when to send an individual home.

#### Student or Staff Ill at School:

- 1. Triage for symptoms of COVID by school nurse
- 2. If Symptomatic of COVID per MCOPH Exclusion Guidelines (COVID-19 Symptoms as listed below)
  - a. Escort student to Health Annex to separate from the general public
  - b. Educate on quarantine and medical follow-up
    - i. COVID testing
    - ii. Exclusion From and Return to School Recommendations (below)
    - iii. Differential Diagnosis
- 3. Student quarantined from school
- 4. No notification unless a positive case is confirmed



### SAMPLE COMMUNICATION: CLOSE CONTACT

#### Communication will be sent to individuals who have been in Close Contact with a confirmed COVID case.

Close Contact means within 6 feet for more than 15 minutes within 48 hours of start of positive case symptoms, with or without use of mask.

#### Good Afternoon,

Yesterday afternoon, [DATE], we were informed by the Montgomery County Office of Public Health that a member of our school community tested positive for COVID-19.

You are receiving this notification because your student was in direct contact with this individual. Direct Contact is identified as being in contact with any individual within 6 feet for at least 15 minutes. According to the Montgomery County Office of Public Health Guidelines, your child will be required to self-quarantine and not return to school for a period of 14 days. This quarantine is in effect from [DATE PERSON WAS TESTED TO 14 DAYS AFTER] as long as your child remains symptom free. During this time, please be mindful if your child experiences any symptoms that may be COVID-19 related. In the event that your child becomes symptomatic, please consult with a medical professional.

In addition, Montgomery County Office of Public Health may be in contact to conduct Contract Tracing. We encourage you to work with the County to provide as much information as possible.

## **IN PERSON AND VIRTUAL LEARNING:** NOVEMBER 12 -FEBRUARY 1 *GRADES K-6*

**GOAL:** SFASD will propose a virtual option for families who desire a home learning option through the second marking period.

### VIRTUAL LEARNING: Attendance

#### Attendance

- The expectation for all students is that they participate in virtual learning 5 days a week from 9:00 am until 3:30.
- Students should follow the designated series of live and synchronous activities that make up the instructional day.

#### PDE Guidance

- We must account for both student's daily access to and completion of assigned learning activities.
- In order for a student to be marked present, they must participate (be seen and participate in the "Live" sessions) and also show an effort to complete the assigned classwork for the instructional block.
- In order to be marked present for the school day, students must participate at the level of the above expectation in Class Meeting, ELA, Science/SS, Math, Specials, and Checkout.
- Students who participate in some of these blocks, but not all blocks must provide a reason as to why they missed their daily instruction. Based on these circumstances, the student may be excused on a one-time basis or marked absent for .5 or the full day.

### **DEDICATED VIRTUAL TEACHERS**: K-6 PROS AND CONS





- Families have an option in addition to In Person and Spring-Ford Cyber Learning
- Familiar model
- Most engaging approach for BOTH the in person and virtual learner.
- Teacher can focus on one set of learners.

#### CONS

- Students should not expect to have the same teacher and classmates as they do right now (both in person and virtually).
- Priority will be to keep teachers consistent, however this may not be possible as we look at each school, class and student need.
- Additional personnel cost
- Transition back to in person learning

### VIRTUAL LEARNING SCHEDULE

This timing does not reflect the time spent on a computer, but rather the duration of the school day. Students will be required to participate in both online and offline components throughout the dedicated synchronous school day. Students will attend school each day of the cycle in a synchronous environment.

**Morning Meeting Conducted Live Each Day:** connect as a classroom community and to engage in social-emotional learning activities.

**English Language Arts (Daily):** Students will follow Journeys Reading Series at a comparable pace to their peers in-person. Daily ELA Block:

- Whole Group Direct Instruction "Live" or Video
- Small Group Instruction "Live"
- Independent Work "Live" or offline (work products will be collected)
- Guided reading groups will also occur "Live" with the purpose of providing small group instruction at the correct level of difficulty.

**Math (Daily):** Students will follow the Everyday Math Program at a comparable pace to their peers in-person. Daily Math Block:

- Whole Group Direct Instruction "Live" or Video
- Small Group Instruction "Live"
- Independent Work "Live" or offline (work products will be collected)
- Guided math groups will also occur :"Live" with the purpose of providing small group instruction at the correct level of difficulty
- ST Math along with other technology driven math support programs will be used as part of the math program (progress will be monitored by the teacher)

#### Science (Daily):

- K-2 Integrated through thematic units.
- **3**-4 Marking Period 2 and 3
- Instruction will involve whole group "live" instruction, small group instruction, and independent synchronous work.

#### Social Studies (Daily):

- K-2 Integrated through thematic units.
- 3-4 Marking Period 4
- Instruction will involve whole group "live" instruction, small group instruction, and independent synchronous work.

**Afternoon Check-In:** connect with as a classroom community at the end of day and provide opportunities for teachers to get feedback on learning from students.

#### Specialists (home school instruction):

- Art, Music, Physical Education, Library (Grades 1-4), Ram Quest (Grades 1-4)
- Class will have a different special each day rotating on a 6-day cycle (one special will be duplicated)
- Special Instruction will be "live" with independent work components.
- 40 Minutes each day.

## **FULL IN PERSON LEARNING:** FEBRUARY 1 – JUNE 17 *GRADES K-6*

**GOAL:** SFASD will continue to be the district that every parent would choose as their child's educational provider

### PLAN TO RETURN TO FULL IN PERSON LEARNING: MP3 + MP4

**Starting November 12, 2020**: SFASD will remain Virtual or In Person only if Montgomery County remains Low or Moderate. SFASD will move back to full Virtual for all students if the County moves to Substantial.

**November 12, 2020 through February 1, 2021:** SFASD will monitor the Level of Community Transmission Table and will provide updates to Spring-Ford families, employees, and board members each Monday

**Starting February 2, 2021:** If SFASD remains in Low for the final four weeks of MP2 the district would propose the elimination of Virtual in MP3

- Must remain in Low from January 4-January 29
- Board approval requested, January 25, 2021 meeting

# FAQ's

#### Q: If we opt for In Person, but have a change of mind, can we change to Virtual after November 12?

A: Due to the need to ensure the safety and efficiency of the delivery of the district's in person, virtual and cyber programs, the selection you make shall be viewed by the Spring-Ford Area School District as a commitment for you and your child to the selected form of education delivery until the end of the Second Marking Period at the earliest. At the Administration's sole discretion, review of current enrollments in all program options will be reviewed and modifications may be made during the course of the 2020-2021 school year as events present or allow.

### Q: If we visit family out of state for the holidays and it is a state designated for quarantine would we need to keep our child home for 14 days upon return?

**A:** Yes, according to the Pennsylvania Department of Health if you have traveled, or plan to travel, to an area where there are high amounts of COVID-19 cases, it is recommended that you stay at home for 14 days upon return to Pennsylvania. <u>Click here for an updated No Travel State list</u>.

### Q: My child has seasonal allergies and/or asthma. How will you determine if they have allergies, asthma, or a COVID symptom?

A: Our School Nurses are trained to assess cases based on a differential diagnosis process. For instance, seasonal allergies do not usually cause shortness of breath or difficulty breathing, unless a person has a respiratory condition such as asthma that can be triggered by exposure to pollen. Symptoms vary from person to person and range from mild to severe. Because some of the symptoms of COVID-19 and seasonal allergies are similar, it may be difficult to tell the difference between them, and you may need to get a test to confirm your diagnosis. You can have symptoms of both COVID-19 and seasonal allergies at the same time. Your child's school nurse will work with your family during the differential diagnosis process.

#### Q: Will my child have a different teacher in person than they have now?

A: Teacher reassignment for both in person and virtual is a possibility. Kindergarten through 6th grade students may be assigned new teachers, both in the virtual and in person environment.

### Q: If for some reason my child's teacher remains a virtual teacher, would it be possible for my child to remain in their virtual class?

A: Kindergarten through 6th grade students who choose to attend school virtually will be assigned to virtual only classrooms, but not necessarily their current teacher if their teacher remains virtual. This will require that many students will be taken out of their current classroom assignments and re-assigned classrooms. This is the only way that an in person AND virtual option can be provided. Families should not made a decision based on what they think their current teacher assignment might be.

### Q: If my family selects virtual, and the entire district is forced to return to virtual at some point, which teacher will my teacher have - the teacher they started with or their virtual teacher?

A: If the district is forced to return to virtual at some point, all students will remain their <u>new</u> class, they will not return to their start of year class.
