

## SCC Meeting October 13, 2020

1. Welcome
2. September Review – due to the windstorm, our September meeting was pushed back a few times. We reviewed the new PBIS plan, Trust Land budget, enrollment is down about 90 students
  - a. Question about funding/enrollment are tied together. One question came up about lower numbers this year and how it will impact our numbers for next year.
  - b. Class sizes
  - c. Outreach for families midyear – support families as the year goes on to get families back to Clayton for the next school year.
  - d. Continue looking at metrics for the school year and next.
  - e. Budget update – rollover came through this week and we are in a good position to continue supporting interventions for students that are reading below a 7<sup>th</sup>/8<sup>th</sup> grade reading level.
3. PTA Report – first meeting went well, looking at dates for a fundraiser. November 5<sup>th</sup> - 16<sup>th</sup>.
4. SIC Report – Currently discussing attendance and how to make it simple and efficient for students and teachers
  - a. Attendance has been very good. The policy for the school year has been updated. Students have a 10-day window for students to complete the work and are marked present
    - i. There is consistent delay of accurate attendance of about a week.
    - ii. Some students continue to choose to not be on live Zoom classes.
  - b. Grades and making them fair and reflect what students are doing remote. Work completion keeps improving as 7<sup>th</sup> graders figure out middle school
5. Counselor Report – been working on homeroom (1<sup>st</sup> period) assignments and activities for kids that revolve around mindfulness, social and emotional learning. Counseling groups will start next week for students who have opted in or parents have reached out.
  - a. CCR meeting start in November. The meetings will be on Zoom. The purpose is to start the discussion about student’s college pathway and future discussions.
  - b. Panel Discussion on Oct. 29<sup>th</sup> – please attend!!
  - c. Student Support – teachers and administrators have identified specific students that need extra support. A limited number of students will get extra support until they are more successful in remote learning.
  - d. Parent input – Once the school is prepared, we are open to putting together plans for small groups. Like dance, PE, etc. More parents feel that students would benefit from being at school in small classes
