 - c. Ensign's scores overall:
 - Math growth scores are lower than previous. This is believed to be due to the new math curriculum and Ensign's difficulty in securing District Coaches. Katherine Kennedy offered to look into this issue again for Ensign. This has been an ongoing issue.
 - ii. Preliminary reading data will be available shortly. EEP Goal is for students to have monitoring 3 times per semester. The reading data should be available for the next SCC meeting.
 - d. What Ensign has done and will do:
 - i. Started student groups for interventions. Heather & Miriam will be doing more interventions
 - ii. Focusing on 3rd Grade and earlier for interventions due to it having the greatest impact on student performance.
 - iii. Hired half-time computer para-pro which will free up more time for interventionists to focus on students

- e. SAGE will be replaced with RISE, a different vendor, to provide year-end testing. Utah owns the data/testing questions, so format might look different, believed RISE will return better data.
- 4. SIC Report: Laura Hamilton is the new SIC representative for this year
 - a. No SIC meeting has happened at Ensign yet.
 - b. The SIC will determine if they want to send a lower grade and upper grade representative to SCC meetings or if one representative is sufficient.
