## **Critical Information**

Please be aware that information provided to the school is not automatically shared with Extended Day staff. <u>Health information, attendance, special needs, custody documents, etc. must be provided to Extended Day,</u> <u>even if previously provided to the school.</u>

## Registration

Students must be re-registered annually. Register online at: <u>https://family.daycareworks.com/login.jsp</u> For assistance please call the Accounts and Billing number above.

Registration for camps will open a month before the first day of the camp, and registration and payment must be completed by the Tuesday prior to the camp date.

ALL 2020-2021 CAMPS WILL BE LOCATED AT CORTE SIERRA ELEMENTARY SCHOOL.

#### **Program Hours**

All Extended Day sites open at 6:00 AM for those registered for AM or AM/PM, and go until the children are released to school staff. PM programs start at the end of the school day and end at 6:00 PM.

#### **Tuition and Payments**

Tuition payments are due on the first day of each month. Payments may be made online via DayCareWorks (\$2 processing fee), or in person at the Community Education Department office: 250 E. Sagebrush St. in Litchfield Park. After-hours payments may be left in the secure drop box in the door. A \$25 late fee is assessed to unpaid accounts on the 5th of the month, and accounts not paid by the 10th will be closed and the child(ren) withdrawn from the program. A 10% discount is applied for a 2nd child registered, 20% for a third child. A 20% discount is applied for LESD employees.

If enrolled in AM-Only or Camp-Only: cost of Early Dismissal Days is an additional \$20.

Single-Day rate available for <u>Minimum Use</u> or <u>Camp Only</u> accounts. Prepay by Thurs. of the preceding week. Single-Day rate is not available for Inservice Days.

NEW: Full-Day Preschool tuition includes Fall and Spring Break Camps, but you must now register your child for these camps in your parent portal account. The accounts of preschool students who are registered for camp but attend fewer than two days will be charged a \$20 staffing fee.

In the event of an unforeseen school closure, you will receive an account credit for the closure days.

## **Release of Students**

Children will only be released to a parent or a person designated on the child's Emergency Information Card. Court documents must be provided if a parent or stepparent is NOT to pick up a child.

## Illnesses/Infestations

If a child is sent home from school or Extended Day with a communicable illness or infestation, they may not return without a doctor's note unless they have been fever-free and symptom-free or the infestation has been eliminated for at least 24 hours. Additional restriction may apply per CDC guidelines re: COVID-19.
