## Private Bus Agreement – Warwick / South County

We understand that you may be interested in using the service of a private bus to transport your daughter to/from St. Mary Academy – Bay View. Please note that our current and only pick-up and drop-off location will be the parking lot between Kohls and Toys R Us (650 Bald Hill Rd., Warwick, Rhode Island).

Due to restrictions and guidelines for COVID-19 set forth by the RIDOH, seating capacity is limited. Seats will not be reserved. Space is available on a first-come, first-served basis. Once capacity is reached, we will no longer accept students to ride the bus. Please note that students cannot have guests ride the bus at any time during the COVID-19 restrictions. A deposit must be received to confirm your reservation. **The deposit is due by Friday, August 21.**

**Students will be required to wear a mask when entering the bus and must keep the mask on during the duration of the bus trip.**

Please select the service you intend to use for the 2020–21 Academic Year below. ***Please note that this agreement is binding for the full school year, and the cost reflects use per student.***

\_\_\_\_\_ I am contracting for the **PM service only**. The cost for this one-way transportation for the full school year is **\$1000.00**. Please return the completed form along with a payment of **\$500.00** no later than **Friday, August 21, 2020**. The remaining balance will be due on **Thursday, October 1, 2020**. **Bus departure is at the conclusion of the school day.**

\_\_\_\_\_ I am contracting for the **AM and PM service**. The cost for this two-way transportation for the full school year is **\$2000.00**. Please return the completed form along with a payment of **\$1000.00** no later than **Friday, August 21, 2020**. The remaining balance will be due on **Thursday, October 1, 2020**.

**It is important to note there WILL NOT be a late bus during the 2020–21 Academic Year.**

I enter into this contract knowing that this payment is in effect even if my child(ren) does not ride the bus for an extended time due to illness, participation in extracurricular activities or for any other reason. Although the contract is payable in two parts, **I am obligated to pay for the full year.**

I am fully aware that my child(ren) is subject to all of the published rules and regulations governing the conduct and safety of the member of the student body. Furthermore, I am aware that at any time, at the discretion of the Principal of St. Mary Academy – Bay View, the student may have her right to ride the bus revoked because of violations of rules, regulations or guidelines.
