Report of the trustees for the year ended 31st March 2020.

The Trustees have pleasure in presenting their Annual Report and financial statements for the year ended 31st March 2020. The financial statements have been prepared in accordance with the accounting policies set out in Note 1, and comply with the Rules of the Foundation, the Charities Act 2011 and Accounting and Reporting for Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland, (FRS 102) (effective 1st January 2015).

Objectives and activities for public benefit

The Foundation exists to

To advance the education of pupils at The Royal Hospital School in particular by:

- 1 Providing Bursaries for the children of seafarers in necessitous circumstances
- 2 Supporting specific projects at the school
- 3 Preserving the heritage of the school and its former pupils and naval background.

Grant-making Policy

The Foundation helps beneficiaries with specific grants. Those claiming assistance are required to provide an application which is considered by the Trustees and after consideration grants are awarded as deemed necessary by the Trustees.

Achievement, performance and public benefit

During the year under review, the Foundation assisted one beneficiaries and continues to build up funds to further its objects. The total expenditure on grants this past year was £ 1,000. (2019: £ Nil)

The Trustees have given careful consideration to the Charity Commission's general guidance on public benefit and have complied with the duty under section 17 of the Charities Act 2011 when determining the type and level of assistance they provide to those applying.

In addition, as set out in the notes to the financial statements the Trustees have considered the effects of Covid-19 on the funds and activities of the Foundation and concluded that whilst the Foundation is affected by the pandemic the financial position and its going concern status are not.

Financial Review

The Foundation's funds are held at present with CAF Bank and no investment income was received in the period.

Risk Management

The major risks to which the Foundation is exposed as identified by the Trustees are reviewed annually, and systems have been established to mitigate those risks on an on-going basis relevant to the size and nature of the Foundation.

Reserves

The Trustees have reviewed the Society's need for reserves, and are currently building funds to enable bursary and support grants to be made. Free reserves amount to £43,815 (2019: £41,071)

Plans for Future Periods

The Trustees continue to look at ways of encouraging RHSA members to donate to enable the funds of the Foundation to be built up.

Structure, Governance and Management

The Royal Hospital School Association's Charitable Foundation (RHSACF) was established as a Charitable Incorporated Organisation – Foundation. It is governed by its constitution dated 15th December 2014.

The charity is governed by its 8 Trustees, listed below. Trustee vacancies are filled by election of the remaining Trustees. Day to day administration of the Foundation is delegated to the Hon Secretary and Hon Treasurer.

All trustees are, or have been, actively involved with the Royal Hospital School and give their time freely and receive no material benefit of any sort as a result of serving. New trustees are provided with induction information by the Hon Secretary who keeps trustees informed of their obligations and duties, and arranges suitable training where appropriate.
