



**Alto Elementary
Parent and Family Engagement Plan
2020-2021**

Alto Elementary is dedicated and fully committed to the academic and social successes of all students enrolled in our school. We firmly believe that parent engagement is an essential piece of the educational process and is a vital component for their students' academic growth and future accomplishments.

1. In support of strengthening student academic achievement, Alto Elementary will reach out to all parents and family members and implement programs, activities, and procedures for the involvement of parents and family members in programs consistent with the requirements of Every Student Succeeds Act (ESSA), Section 1116. These programs, activities, and procedures shall be planned and implemented with meaningful consultation with parents of participating children. Section 1116 (a)(1)

- Alto Elementary will ensure that the required school-level parental involvement policies meet the requirements of ESSA Section 1116, and each include as a component a school—parent compact.
- Alto Elementary will incorporate this campus parental involvement plan into its campus improvement plan.
- In carrying out the Title I, Part A parental involvement requirements to the extent practicable, Alto Elementary will provide full opportunities for the participation of parents with limited English proficiency, parents with disabilities, and parents of migratory children; including providing information and school reports in an understandable and uniform format including alternative formats upon request, and, to the extent practicable, in a language parents understand.

2. Alto Elementary receives Title I, Part A funds. Our goal is to plan and implement effective parent and family involvement activities to improve student academic achievement and school performance. Therefore, Alto Elementary will develop jointly with, agree on with, and distribute to, parents and family members of participating children a written parent and family engagement plan. - **Alto Elementary will take the following action and incorporate this plan with the involvement of parents into its Campus Improvement Plan (CIP) under section 1112:** Annual Federal Program Title I Meeting; Campus Site Based Meeting, District Improvement Committee Meeting; Campus Parent Night/Meetings; and Private Non-Profit Meetings.

3. Alto Elementary will involve parents and family members in jointly developing the Campus Improvement Plan (CIP) under section 1112 and the development of support and improvement plans under paragraphs (1) and (2) of section 1111 (d). Section 111 (a)(2)(A)

- **Alto Elementary will take the following actions to involve parents in the process of school review and improvement under section 1116:** Newsletters (District/Campus); Written Notifications; Grade Reports; Assessment Data; and

Parent Meetings, and participation on the Campus and District Meetings.

4. Alto Elementary will provide the following necessary coordination, technical assistance, and other support to assist and build capacity in planning and implementing effective parent and family involvement activities to improve student academic achievement and school performance, which includes meaningful consultation with employers, business leaders, and charitable organizations, or individuals with expertise in effectively engaging parents and family members in education. Section 1116 (a)(2)(B)

- **Alto Elementary will take the following action to incorporate this plan with the assistance of its Title I, Part A schools, and community organizations to provide support to parents of children served by the district, as appropriate, in understanding the following topics by undertaking the actions described in this paragraph:** the State's academic content standards; the State's student academic achievement standards; the State and local academic assessments including alternate assessments; the requirements of Title I, Part A; how to monitor their child's progress; and how to work with educators.
- Parents will be provided the opportunity to attend or receive information by participating in the following: STAAR Curriculum Nights, Written Documentation, and Parent-Teacher Conferences/Meetings (virtually due to covid).
- **Alto Elementary will provide materials and training to help parents with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement by:** providing necessary training for parents from Title I, Part A funds, if the school district has exhausted all other reasonably available sources of funding for that training; pay for reasonable and necessary expenses associated with parental involvement activities, including transportation and child care costs, to enable parents to participate in school related meetings and training sessions; training parents to enhance the involvement of other parents.
- **With the assistance of parents, Alto Elementary will educate its teachers,**

counselors, principals and other staff on effective ways to communicate and work with parents as equal partners; also, on how to implement and coordinate parent programs to build ties between parents and schools by: providing in district access to student and community health services via MOA with Anderson Cherokee Community Enrichment Services (ACCESS); involving parents in the development of training for teachers, principals, and other educators to improve the effectiveness of that training; and adopting and implementing model approaches to improving parental involvement.

- **Alto Elementary will take the following actions to ensure that information related to the school and parent programs, meetings, and other activities is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request and, to the extent practicable, in a language the parents can understand:** meeting minutes (available upon request), newsletters, parent notes, and maximize parental involvement and participation in their children's education by arranging school meetings at a variety of times, and conducting conferences via phone or zoom.

5. Alto Elementary will coordinate and integrate parent and family engagement strategies under Title I, Part A, to the extent feasible and appropriate with other Federal, State, and local laws and programs, including public preschool programs, and conduct other activities that encourage and support parents in more fully participating in the education of their children.

- Prekindergarten Round-UP Registration, Open Computer Labs and translator during school registration, ARD Meetings, 504 meetings, LPAC meetings, Parent-Teacher Conference; offer a flexible number of meetings, such as in the morning or in the evening, and partnership with other community organizations. We also offer family friendly events such as Meet the Teacher, Grandparent's Day, Veterans Day, etc. (Currently not holding in person events due to COVID.)

6. Alto Elementary will conduct, with meaningful involvement of parents and family members, an annual evaluation of the content and effectiveness of the parent and

family engagement plan in improving the academic quality of all schools served under this part, including identifying—Section 1116 (a)(2)(D)

- **The evaluation will include identifying barriers to greater participation by parents in parental involvement activities. The school district will use the findings of the evaluation about its parental involvement policy and activities to design strategies for more effective parental involvement and to revise, if necessary (and with the involvement of parents), its parental involvement policies through:** on-line parent surveys—Campus

Administration and staff will inform parents of the availability of survey through the campus and district web-site, District Facebook page, timely information about Title I, Part A programs, description and explanation of the curriculum used to measure student progress and the achievement levels of the challenging State academic standards, and campus site-based meeting feedback and district advisory council meeting feedback.

7. Alto Elementary will involve parents in the activities of the schools served under Title I, Part A which may include establishing a parent advisory committee comprised of a sufficient number and representative group of parents or family members served by the district to adequately represent the needs of the population for the purpose of developing, revising, and reviewing the parent and family engagement policy and provide such other reasonable support for parental involvement activities under Section 1116, as parents may request.

- **In order to build consistent, effective and timely communication and partnerships between the home, school, and community, Alto Elementary will provide regular communication through the following:** Campus Site Based committee, District Improvement Committee, PTO organizations (not now due to COVID), Annual Federal Program Title I Meeting, Campus Parent Nights, Campus and District Newsletters, BlackBoard Alert via phone and text in English and

Spanish, School Assemblies, District Facebook page, District Website, Campus Websites, Annual School Calendar, school marquee, google classroom, student emails, Remind 101, and Channel 7, Channel 56.

- **All written communication will be provided in English and Spanish to reflect the needs of the district student population. The district will also provide translation, if needed, during parent meetings and programs.**

A Parent's Right To Know

As a parent or guardian of a student at a Title I campus, you have the right to know the professional qualifications of the classroom teachers who instruct your child.

Federal law allows you to ask for certain information about your child's classroom teachers, and requires the District to give you this information in a timely manner if you ask for it. Specifically, you have the right to ask for the following information about each child's classroom teachers:

- Whether the State Board for Educator Certification (SBEC) has licensed or qualified the teacher for the grades and subjects he or she teaches.
- Whether the State Board of Educator Certification (SBEC) has decided that the teacher can teach in a classroom without being licensed or qualified under state regulation because of special circumstances.
- The teacher's college major, whether the teacher has any advanced degrees and, if so, the subject of the degrees.
- Whether the teachers' aides or similar paraprofessionals provide services to your child and, if they do, their qualifications.
- Information on the level of achievement of the parent's child in each of the State academic assessments as required under Section 1111 (h)(6)(B)(i).
- Timely notice that the parent's child has been assigned to, or has been taught for four or more consecutive weeks, by a teacher who is not highly qualified under

Section 1111 (h)(6)(B)(ii).
