### A LETTER OF RECOMMENDATION (OPTIONAL)

This can come from a teacher or counselor. Letters may be submitted through the Common Application, emailed to admission@ collegeofidaho.edu, or students may upload them to their Application Portal.

### \* WHAT IS TEST OPTIONAL?

A student chooses to apply Test Optional by marking on their application whether or not they want to use their test scores in the admission process. Once a student submits their application, they cannot change their decision. When a student applies Test Optional, instead of standardized test scores, The College of Idaho considers the following factors for both admission decisions and academic merit scholarships:

- Recalculated Academic GPA
- Strength of Curriculum
- Additional materials to complete Test Optional process

If available, a student may still submit their standardized test scores for advising purposes and course placement.

# SCHOLARSHIPS & FINANCIAL AID

### FREE APPLICATION FOR FEDERAL STUDENT AID

Families are strongly encouraged to submit a FAFSA on or before the time their student receives their admission decision. This way, any need-based scholarships they may qualify for are included in their financial aid package.

### **INITIAL FINANCIAL AID PACKAGE**

Students will receive their initial Financial Aid Package within two weeks of receiving their admission decision. Students are automatically considered for Academic Merit Scholarships. Whenever the student receives an additional scholarship, such as a talent scholarship or Kathryn Albertson Scholarship Competition award, their financial aid award is updated through their C of I Portal.

### **SCHEDULE A FINANCIAL AID MEETING**

Most students choose to plan Financial Aid Meetings in early Spring after they have received their financial aid packages. Our admission team will create an Estimated Cost Worksheet as an idea of what they can anticipate from their final bill.

### **TALENT SCHOLARSHIPS**

Talent Scholarships are available to incoming students and are determined by the directors or coaches of each talent area. Students do not need to major or minor in a specific fine arts program to receive a scholarship from that department. They only need to participate in the program.

### FINE ARTS SCHOLARSHIPS AUDITIONS

At this time, Fine Arts Auditions are being held virtually and can be scheduled through your student's admission counselor. We hope to be able to offer in-person audition dates later in the academic year.

### KATHRYN ALBERTSON SCHOLARSHIP COMPETITION

Students may register for the scholarship competition after November 15, and must have at least a 3.0 cumulative GPA and submit an application for admission to The College of Idaho. The competition consists of a written essay and an interview with a faculty member. Each participant will receive \$500, with runners-up receiving \$1,000, and competition winners receiving \$2,500 a year in scholarship support.
