

# Lisle Community Unit School District 202 Illinois Public Act 095-707

In conformity with sub-section (b) of Section 10-20.44 of the Illinois School Code [105 ILCS 5//10-20.44] as enacted by Public Act 095-707, a school board must list on the district's Internet website all contracts over \$25,000 and any contract that the school board enters into with an exclusive bargaining representative.
