So that as many Novi students as possible can attend the annual 8th grade trip to Washington DC, Novi Youth Assistance (“NYA”), the Novi Educational Foundation (“NEF”) and the Novi Middle School PTO (“PTO”) will be pooling our resources to provide scholarships to students in need. The three entities will coordinate awards based on this one application. Because the NYA uses Community Development Block Grant funds to offset the cost of some of its programs, it is a bit more limited in who can receive funds (per chart on following page). However, the NEF and PTO have more flexibility to assist families whose incomes exceed the levels on the following page, but still struggle to cover the expense of the DC trip. Additionally, the NYA can only provide funds to residents of Novi, but NEF and PTO can provide assistance to any student attending Novi Schools.
