Davis Tech Program Disclosure Statement

The Davis Technology College (Davis Tech) is an opportunity for our students to participate in a COLLEGE level learning experience. Davis Tech is a separate entity from the Davis School District (DSD). By signing up for classes at Davis Tech you will be responsible for your educational experience, i.e.: grades, attendance, communicating with your instructor, classroom fees, and supplies. The objective of the Davis Tech programs is to provide opportunities for skill development, work experience and career preparation. Standards have been established that will enable each student to maximize their possibilities for success.

Students enrolled in a Davis Tech program agree to the following:

1. Do quality work in the training program
2. Arrive to class on time. Attendance is an important part of the Davis Tech grade. Students must maintain 80% attendance. Davis Tech grades will be issued by the college instructor and may be adjusted based on poor attendance as explained below:
 - If your attendance drops below 80% your grade will be affected as follows:

79% - 75% 1 grade drop	74% - 70% 2 grade drops
69% - 65% 3 grade drops	64% - 60% 4 grade drops

Example: If Davis Tech Instructor gives you a B and you have 72% attendance you would receive a C+: B subtract 2 grade drops = C+
 - Attendance or progress below 60% will result in an automatic F and U
3. Excessive tardiness or inappropriate behavior may result in a "U" and/or removal from the Davis Tech Program.
4. Neither the district nor the school is responsible for student transportation to and from Davis Tech. The student's parents or guardian has sole responsibility for providing the student transportation to and from Davis Tech.
5. Students not meeting these requirements may be pulled from Davis Tech and will lose credit for the term.
6. If you plan to miss your Davis Tech classes for an authorized school-related activity, you must complete the **Activity Excuse Form** at least one day in advance, have it signed by the CTE Office and submit to your Davis Tech instructor. The activity will not be excused if the form is not submitted and permission granted by your instructor **prior to the event.**
