Changes to December Calendar

With Winter Break quickly approaching and COVID cases (or CLOSE CONTACT QUARANTINE cases) on the rise, our hope is that every student, all employees, and every member of your family will be well and out of quarantine for the holiday season. Working toward that end, we are announcing the following significant schedule change.

As you know, our last day of instruction before winter break is December 15. However, we will not hold classes **on campus** on December 14th or 15th. Instead,

- students in grades 4-12 will be DIGITAL LEARNERS on December 14th and 15th.
- students in grades K-3 will receive enrichment and intervention materials and resources to work on at home.

Each school will provide detailed information to support learning on these two days. With this change, the last day for on-campus classes will be Friday, December 11. Hopefully, these extra days at home and the break to follow will be a welcome respite for everyone.

Digital devices will be sent home with all 4-12 grade students, including day users, during the Thanksgiving and Winter breaks. Students in grades K-3 will not require a device for home use.

Adventure Club will be OPEN on December 14th and 15th.

Again, no ON-CAMPUS classes will be held on December 14th and 15th. Instruction for grades 4-12 will be DIGITAL ONLY during these two days. Elementary teachers will provide specific directions and plans for K-3 students, who will also be at home on December 14th and 15th.

Distribution is on a first-come, first-served basis. No sign-ups are required.

Toy and gift distribution is for children newborn to 15 years.

How to qualify:

- *Proof of ID in the form of Social Security Card, birth certificate, library card, school id, insurance card, etc. for **each child**.
- *Proof of residency in Blount County (address on state ID, utility bill, etc) for parent/guardian.
- *If the adult present is not the parent, proof of guardianship.
- *No other assistance has been provided by other agencies for child. (We link with United Way and other charitable agencies. Families may be assisted by only one organization for Christmas gifts.)

Changes to Instructional Method

The next opportunity to notify us of a desire to switch instructional options is by **noon on Friday, December 11th**. Those changing at this time would begin their new method of instruction upon return from winter break, (January 5th).

Families are limited to changing instructional options one time for the entire school year. Please call the office at 865-983-8551 if you plan to switch.

Contact Tracing

We need your help! As we continue to work toward solutions to keep as many students in front of as many teachers for as many days possible, one big area of challenge is Close Contact Tracing. We believe the following actions can help to minimize the number of students who are required to quarantine due to being a close contact:

1. Please keep your student at home if symptomatic. The guidelines are to stay home for 10 days for COVID-level symptoms. Sometimes just taking one day at home will help parents or physicians determine if the symptoms are actually COVID level or not.
2. If you are considering giving your child a COVID test or are awaiting the results of a COVID test, please keep your child at home until a determination is made and results are provided. Initially, the guidance from the health department was to not test until symptomatic. However, we are now seeing an increase in testing regardless of symptoms. At this time, we ask that you keep your student at home even if you choose to administer a test to your child without symptoms out of an abundance of caution.
3. If your child has been in close contact with a person outside of the school environment who is positive, please take action and inform the school and keep your child home for 14 days. The close contact definition is proximity to an infected person for longer than 15 minutes and less than 6 feet with tracing beginning 48 hours prior to the onset of symptoms or a positive test. If you know your child is a close contact to an infected person, please take this action even if the Health Department never contacts you to officially identify your child as a close contact. The school will happily accept your parent report of Close Contact and will follow-up by providing digital instruction to your student for the 14-day isolation period.
4. Immediately inform the school of all positive test results. These actions are critical to COVID management at the school and district level. If the "possibly positive" student stays at home until the test results are provided, that eliminates all of those days for close contact tracing because for each positive case, we are required to look back 48 hours to identify close contacts based on the 6 foot/15 minute guidance.

The only chance we have to prevent spread is for sick kids and adults to stay home and for everyone to work as a team on proactive strategies. We appreciate your cooperation.

MCS Student COVID-19 Decision Tree

Protecting Staff and Children During the COVID-19 Pandemic

Students should be kept home from school for the following reasons:

- Positive COVID-19 test or awaiting test results**
- Symptoms of COVID-19**
- Close contact with confirmed positive for COVID-19**

OR

Students with COVID-19 symptoms will become ill at home and will be absent from school until they are symptom-free for 24 hours.

Determine if your child should be sent to school and other necessary actions using the chart below.

Child has received a positive COVID-19 test or is awaiting test results

- Notify your child's class
- Leave child at home for 10 days from the onset of symptoms or 30 days from test date
- Must be symptom-free for at least 24 hours before returning to school
- Child must wear a mask when returning to school

Child is exhibiting a cough or high-risk indication of COVID-like symptoms

- Notify your child's class
- Child must wear a mask when returning to school

*Close contact is considered being within 6 ft. of a person for 15 minutes or more, the window for close contact tracing is 2 days before the onset of symptoms or 2 days before the test date if asymptomatic.

Someone in your household tests POSITIVE for COVID-19

If the POSITIVE case is a student, the school will issue a 14-day isolation notice. If the POSITIVE case is an adult, the school will issue a 14-day isolation notice. If the POSITIVE case is a child, the school will issue a 14-day isolation notice.

The Health Department will conduct telephone interviews to determine isolation plans for all household close contacts. Contact the ability to fully quarantine the positive individual from the household.

IS IT POSSIBLE TO FULLY QUARANTINE SOMEONE IN THIS HOUSEHOLD?

NO

Household Close Contacts will not attend the positive person's activities and will not begin the 14-day close contact isolation. The Health Department will notify the school and the family should follow Health Dept guidance and not return to school until the full isolation period is complete.

YES

The Health Department must have assurance and evidence that the positive case will not share any long-term activities, including sleeping, eating, and playing, with anyone in the household. Household Close Contacts can then follow the 14-day isolation period to return to school after a 14-day isolation.

HOUSEHOLD CLOSE CONTACT

CLOSE CONTACT TRACING for household members begins two days after the positive person is identified. Household Close Contacts are defined as anyone who has been in contact with the positive person for 15 minutes or more within 6 feet of the positive person. 
