Field Environmental Consulting, Inc. (FIELD ENVIRONMENTAL) appreciates the opportunity to provide results for radon monitoring conducted at Oak-Land Middle School.

Radon levels are measured in picocuries per liter or pCi/L. The Environmental Protection Agency (EPA) and the Minnesota Department of Health (MDH) action level for indoor radon is 4.0 pCi/L.

Radon monitoring was conducted using AccuStar® PicoCan 275 short-term open face charcoal canisters (registered device #AC-6048).

In February 2019, eighty-nine (89) detectors were analyzed for radon concentration. All samples were below the action level of 4.0 pCi/L. No additional action necessary.






