This year we had the opening of virtual

Tom Leonard: It's been a challenge for our staff definitely a challenge for our staff and we're working with blended learning and we have 45 00:07:18.510 --> 00:07:36.570 Tom Leonard: All kinds of protocols that are connected to COVID 19 trying to keep people safe and keep sustained learning and keep us operational we've had to adapt assessments and adaptive curriculum and there's no doubt it's a challenge engaging students, some students thrive 46 00:07:38.010 --> 00:07:43.590 Tom Leonard: In this current environment, but some are really struggling and there's no doubt about that. And some struggle with 47 00:07:44.100 --> 00:07:49.620 Tom Leonard: Remote learning and some struggle with some of the protocols in place, even in person learning so 48 00:07:50.130 --> 00:08:06.000 Tom Leonard: It had we've had a lot of challenges so tonight. What I really want to do is break this into three parts. I want to spend a little time just saying, what is our current stance. What's going on right now. Where are we, and then I want to move and I want to go to looking forward 49 00:08:07.170 --> 00:08:14.220 Tom Leonard: Talk a little bit about what I anticipate happening in the next couple weeks into the next semester. I'll just a quick look with some pictures a little talking about what's happening in the schools. 56 00:09:19.470 --> 00:09:29.310 Tom Leonard: And also talking about some of the Community support some of the testing programs that we put together and some things that you will see coming up in the future. So enrollment percentages. 57 00:09:30.360 --> 00:09:37.530 Tom Leonard: Those are. This is where we are and I, there's a lot of numbers on this screen. This is the last time people selected, whether they wanted to be remote 58 00:09:37.980 --> 00:09:49.740 Tom Leonard: Or where they want to be in person high level. Right now we're about 60/40 about 40% of the kids in person answer 40% of the kids remote 60% of the kids in person. 59 00:09:50.580 --> 00:10:00.990 Tom Leonard: There's no right or wrong certain things work for some kids and their parents certain things work for others. We just want to make it work for whatever those parents choose and hopefully they at the 60 00:10:01.290 --> 00:10:22.770 Tom Leonard: Upper level that's a conversation between the parents and the child, but it ranges. If you look for example at the high school,

we're roughly around 50/50 we've got about 52% remote 50 48% just just about 50/50. And if you look at a school like Bridge Point, for example. 61 00:10:23.910 --> 00:10:40.230 Tom Leonard: On October 19, 77% in person 23% remote. So we're making it work wherever those percentages go and those percentages could change in the next semester. You know, we would love to see absolutely zero positive cases well 63 00:10:52.290 --> 00:11:07.860 Tom Leonard: This is a very contagious virus. So, that is not the case. The actual number of cases that we have this week. Wow, this is, this is from a day or so ago, but was at 12 is actually lower than it's been in past weeks we've had numbers higher than that in the past. 64 00:11:09.030 --> 00:11:17.820 Tom Leonard: What we're finding and I think this is something that's important to make clear to people, most of our cases, you know, 65 00:11:19.620 --> 00:11:32.340 Tom Leonard: Originate not in our schools and why why do I believe that the reason I believe that is in cases where we do have to quarantine. Some kids who were next to a positive case. 66 00:11:32.760 --> 00:11:45.870 Tom Leonard: And the vast majority of situations because our protocols are good and because kids are wearing masks and because we're trying to social distance as much as possible, we are not getting spread to those kids in quarantine. 67 00:11:46.950 --> 00:11:55.620 Tom Leonard: Now we're following the rules from CDC, which are aligned with TEA, which are aligned with Austin public health. So we are doing the quarantine piece. 68 00:11:55.980 --> 00:12:04.590

Tom Leonard: But what we find out. Typically, is that the cases come from social gatherings that are happening outside the school and that are being brought in. 69 00:12:05.610 --> 00:12:09.180 Tom Leonard: At one point, last week I think we had 70 00:12:10.470 --> 00:12:29.610 Tom Leonard: Maybe off a little bit on the number, but maybe 16 students at the high school who were active cases. And it turned out, only one of those kids was doing was in person academic now some of those kids could have been in person for athletics, but they were remote for their learnings so 71 00:12:30.630 --> 00:12:39.630 Tom Leonard: Sometimes you'll see a number and it says in person, but a lot of those kids are not in person in the schools. So this is a dashboard. That's updated daily 72 00:12:40.110 --> 00:12:56.670 Tom Leonard: It will not be updated. Once we hit on Monday of next week, we are not in we won't necessarily getting the information. But as soon as thanksgivings over will update it as soon as possible. I also want to just, you know, we typically it's common to have parents and 73 00:12:58.440 --> 00:13:08.550 Tom Leonard: Coming into our schools. But this year because of Covid 19 like every school district around we really limited visitors. But I can tell you when I walk into our schools. 74 00:13:09.720 --> 00:13:11.400 Tom Leonard: There is a good energy 75 00:13:14.100 --> 00:13:25.890 Tom Leonard: Yes, kids are wearing masks and they're doing a great job wearing masks. We're not really having to enforce that in any big way. The kids know what's going on, and even the little kids seem to be fine with it. I've seen such creativity and some of the masks. 76 00:13:26.250 --> 00:13:31.350 Tom Leonard: We have plexiglass all over the place. And I'll mentioned

We are upgrading our gig 79 00:13:54.330 --> 00:13:59.700 Tom Leonard: Output significantly from one to six just over on 80 00:14:01.590 --> 00:14:11.490 Tom Leonard: Just over the, over Thanksgiving break will actually go six times in terms of our bandwidth in our schools. So we're happy that we're gonna be able to make that happen. 81 00:14:13.890 --> 00:14:17.130 Tom Leonard: Next, I just want to talk a little bit about some things and thank the community. 82 00:14:17.910 --> 00:14:27.900 Tom Leonard: We do have a wonderful community. And yes, there are times where we don't all agree on everything. I was on a call last week with some of our community members who wanted to get this up and running and we weren't sure how many people would come

And then we also will be doing that on Sunday. And now that we know that there's a demand and we can do it. And we can do a drive through, we will 88 00:15:23.850 --> 00:15:26.160 Tom Leonard: We'll look for some other dates to do that in the future. 89 00:15:27.720 --> 00:15:36.240 Tom Leonard: This morning, actually we tested TEA gave us 2000 antigen tests. So we have those in house. Those are the tests that 90 00:15:37.740 --> 00:15:45.390 Tom Leonard: are about 98% accurate and they take about 15 minutes to get your results and we had a small group of 91 00:15:45.750 --> 00:15:55.620 Tom Leonard: Staff go through that in fact I was I was out there. I just want to see how it worked and went through it myself. And wasn't that bad or pretty efficiently. 92 00:15:56.100 --> 00:16:04.830 Tom Leonard: We'll get better at it and we plan on we asked for volunteers in the community and Molly May says we will have over 100 people in the community parents who volunteer to help us test. 93 00:16:05.160 --> 00:16:14.100 Tom Leonard: And we'll be doing a course for those parents next starting will return from Thanksgiving to get them prepared because there's a few things you need to know how the whole system works.

And during all the things that we're dealing with right now. And that'll be December 10 at 6pm you'll get more information on that later. All they raised donations to you know quite a bit of money so that they could put plexiglass and many of our classrooms and they're still working on that project. If you're interested in

But last year was \$2.5 million. But as we started this year. They knew this year was different. 107 00:18:51.990 --> 00:19:02.310 Tom Leonard: And they asked us what do we need and we said. you know. we need some bodies we need more people in there and I need people I can put here are put there if I need it and we're hiring teachers as fast as we can in certain situations. We can put them in right away and the relationships are always already there and it's so helpful. So thank you to EEF

We had to start virtual for three weeks, which we did

it. I don't know what the next numbers will be. This is a graph, we used a long time ago. Some of you knew that we started at 25% to get our protocols in place that was guidance from Austin public health 130 00:22:49.800 --> 00:22:57.210 Tom Leonard: We bump that up on September 21 and since September 21 we pretty much have been, what do the parents want 131 00:22:57.990 --> 00:23:05.010 Tom Leonard: And we've got 60% in some buildings 50% in some buildings and it's pretty much stayed the same when you 132 00:23:05.820 --> 00:23:12.330 Tom Leonard: When you play that forward into the next area. You can see the other weeks, if we went from about 4852 133 00:23:12.750 --> 00:23:21.900 Tom Leonard: To 4060. And so that was that the grading period with that change. And I don't know where it will change it. The next grading period because we haven't done the re-selection process yet 134 00:23:22.560 --> 00:23:28.500 Tom Leonard: Once I do the ones who put that out there. Do you want remote, do you want in person. 137 00:23:48.450 --> 00:23:57.090 Tom Leonard: And we'll open that up for one week and will open on Monday, November 30 it'll close December on Friday, December 4 and then that gives us 138 00:23:57.420 --> 00:24:07.320 Tom Leonard: Two weeks for us to do whatever we might need to do to make any changes if needed between different classes, make sure we got things set. Try to keep the teacher relationships with the kids together. 139 00:24:07.800 --> 00:24:17.370 Tom Leonard: And everyone will know what's going on, as we're going into winter break and then when we come back we'll be ready in that third quarter. So this will be happening on November 30 140 00:24:19.650 --> 00:24:22.740 Tom Leonard: But I want to make something extremely clear 141 00:24:24.060 --> 00:24:26.100 Tom Leonard: Our primary objective. 142 00:24:27.930 --> 00:24:32.460 Tom Leonard: My primary objective is to stay open. 143 00:24:35.760 --> 00:24:37.410 Tom Leonard: I want to stay open. 144 00:24:38.640 --> 00:24:53.160 Tom Leonard: We can do this. I really do believe we can do this. Yes, it's not perfect. Yes, we have guarantines yes, some people are getting the virus. I get that. But even if we were fully remote, there's a chance. Some people will get the buyers. 145 00:24:54.570 --> 00:25:04.140 Tom Leonard: But we need to do everything we can do and work as a

community to stay open because that's good for kids. And it's good for my staff and it's good for the community. 146 00:25:04.710 --> 00:25:17.190 Tom Leonard: So there are some adjustments we are making and we gave a survey to our staff and I'm not going to read all these questions. But, you know, how are they doing, and said to get some stress and 147 00:25:17.790 --> 00:25:26.940 Tom Leonard: One theme kept coming through and every question we asked, what would be the thing we can give to you. If there's one thing we could give to you, what would it be and it was additional time 148 00:25:27.690 --> 00:25:39.840 Tom Leonard: We need time whether it's for self care or whether it is for to get prepared for their lessons or whatever it might be, they're living in a whole nother world doing their job in a whole different way and they need time 149 00:25:40.710 --> 00:25:56.280 Tom Leonard: And so the trustees directed me to see what we could do. And what I did was I directed Dr Arnett to see what we could do, and I'm going to bring Dr our net on if that's okay. And Jeff, if you can 150 00:25:57.810 --> 00:26:05.340 Tom Leonard: walk them through what we worked with, with the district leadership team. And then how that then played with the board vote on Tuesday night. 151 00:26:06.330 --> 00:26:16.890 Jeff Arnett: Sure. Thanks Dr. Leonard each year. The district leadership team is responsible for developing our academic calendar and they then make that recommendation to the Board of Trustees. 152 $00:26:17.250 \longrightarrow 00:26:25.920$ Jeff Arnett: So it has to go back to the district leadership team if we make any adjustments to the calendar and the board as Dr. Leonard said asked the DLT to 153 00:26:26.280 --> 00:26:36.360 Jeff Arnett: Take this up as a project and see if we might be able to

find time for our staff and our students, which will point out in just a moment. So Dr. Leonard, if you look at the next slide. 154 00:26:37.110 --> 00:26:42.330 Jeff Arnett: This talks about the concept that the district leadership team came up with and they 155 00:26:42.930 --> 00:26:53.310 Jeff Arnett: Would consider these breaks or our teachers and for our staff, we're going to be adding eight early release days to our calendar, beginning in December. 156 00:26:53.700 --> 00:27:02.400 Jeff Arnett: Most of these are going to be blocks of back to back early release days, two consecutive early release days on occasional Wednesdays and Thursdays. 157 00:27:02.760 --> 00:27:14.700 Jeff Arnett: But the whole purpose of these is not to give teachers and staff time off, but rather to give them time for their own mental health time when they can manage their classroom projects and responsibilities. 158 00:27:15.360 --> 00:27:25.380 Jeff Arnett: Their own schedules and plan for the next day or the upcoming weeks in our classroom. This is what the current calendar looks like as we go to the next slide. 159 00:27:26.070 --> 00:27:34.860 Jeff Arnett: This shows you where we have some early release days that were built into the current calendar, you'll see one of those right now on December the 18th 160 00:27:35.280 --> 00:27:46.080 Jeff Arnett: That's the traditional final day of the semester before everybody goes away for the winter vacation. There's a similar one on May the 26th at the end of the year before everybody goes into summer vacation. 161 00:27:46.500 --> 00:27:57.030 Jeff Arnett: Then we had a couple of other other early release days in March and April, but now the next calendar will show you what the

eight additional early release days will look like when we layer these in 162 00:27:57.480 --> 00:28:06.690 Jeff Arnett: So we're going to introduce one of these as a kind of standalone pilot on December the 10th that's going to be valuable to our teachers and our principals, because 163 00:28:07.140 --> 00:28:13.920 Jeff Arnett: We will have just completed the selection process that Dr. Leonard talked about a moment ago that will give our staff, the time when they can 164 00:28:14.160 --> 00:28:22.110 Jeff Arnett: See the results of that and plan for what their class lists will look like, who will be remote who will be in person when students return in January. 165 00:28:22.560 --> 00:28:32.850 Jeff Arnett: But then in February, March, April and May. You'll notice those kind of pink right triangle boxes, back to back on consecutive days. Those are the thought breaks 166 00:28:33.300 --> 00:28:40.830 Jeff Arnett: And those two consecutive days are strategically placed rather than doing random early release days throughout the month. 167 00:28:41.220 --> 00:28:54.540 Jeff Arnett: We know those are challenging for parents. And so we wanted to give you two consecutive days for the benefit of staff and students but also for parents so that you can plan ahead and these are already published on our calendar. 168 00:28:55.230 --> 00:29:00.720 Jeff Arnett: So the next slide talks about the benefits of doing the back to back early release days. 169 00:29:01.110 --> 00:29:10.590 Jeff Arnett: And those single early release days, as I said, if you just kind of sporadically place those through the calendar that interrupts instruction, you had these fragmented weeks.

170 00:29:11.100 --> 00:29:17.370 Jeff Arnett: And the district leadership team felt very strongly about preserving the quantity and the quality of instructional time 171 00:29:17.880 --> 00:29:22.650 Jeff Arnett: So two early release days on consecutive days create these thought blocks. 172 00:29:23.340 --> 00:29:32.580 Jeff Arnett: Where you can deliver instruction in longer concentrated blocks of time because on a typical early release day you have a compressed schedule the 173 00:29:33.000 --> 00:29:41.430 Jeff Arnett: Class periods at the middle schools and the high school or shorter teachers at the elementary level have less time to devote to students on an early release day 174 00:29:41.910 --> 00:29:47.010 Jeff Arnett: So the benefit of this for example would be that, let's say in the middle schools in the high school 175 00:29:47.460 --> 00:29:54.810 Jeff Arnett: A teacher or students could have periods, one through four on the first early release day and then the very next day. 176 00:29:55.410 --> 00:30:01.710 Jeff Arnett: The students and teachers would return for periods five through eight so you're able to keep those days back to back. 177 00:30:02.430 --> 00:30:12.570 Jeff Arnett: And really have a focus on quality instructional time, even at the elementary level. If you have a child in Spanish immersion, for example, that would allow the English teacher to teach on the first day. 178 00:30:13.020 --> 00:30:22.830 Jeff Arnett: And then the Spanish teacher to teach on the second day and vice versa, or in grades four and five, where we have departmentalized subjects like math and science and social studies and language arts

179 00:30:23.370 --> 00:30:33.810 Jeff Arnett: They can have some subjects on the first day and then flip in the block on the second day and have the other subjects, back to back. So it preserves that continuity of instruction. 180 00:30:34.200 --> 00:30:40.770 Jeff Arnett: So that's what we're trying to achieve here and that's why we wanted to be thoughtful in the way we scheduled the early release days. 181 00:30:41.220 --> 00:30:54.240 Jeff Arnett: The next slide talks about the benefits for teachers. So for our staff, we wanted to provide these thought breaks for their mental health, give them time to manage their schedule and plan. It's not time off. 182 00:30:54.630 --> 00:30:58.920 Jeff Arnett: They're still going to be in the buildings working and planning, on behalf of the students 183 00:30:59.340 --> 00:31:05.730 Jeff Arnett: But for the students themselves. There's also a benefit because we think what is good for our teachers and for our staff. 184 00:31:06.090 --> 00:31:15.270 Jeff Arnett: Can be good for students to and they also need a little bit of a mental health break as well. Finally, for parents because we know that's who's primarily on tonight's webinar. 185 00:31:15.810 --> 00:31:23.940 Jeff Arnett: We understand that early release days are not always convenient. We know that childcare, especially if you have younger children can be a challenge. 186 00:31:24.450 --> 00:31:30.330 Jeff Arnett: So if your child is currently in one of our child care programs, whether it be easy care or CDC. 187 00:31:30.750 --> 00:31:37.050 Jeff Arnett: those options are still there for you, even on these

early release days we're making accommodations for children of our staff. 188 00:31:37.380 --> 00:31:45.990 Jeff Arnett: We're also trying to work with some partners in the community so that they might be able to provide childcare on those early release days and get more options to families. 189 $00:31:46.470 \longrightarrow 00:31:58.980$ Jeff Arnett: And for families that depend on lunch. While there won't be meal service on those days, we are going to create a grab and go lunch option for children so that even as they're on their way out the door to the bus or to get in car with mom and dad. 190 00:31:59.280 --> 00:32:09.690 Jeff Arnett: Or whoever their caregiver might be that day, they can grab a lunch and still have a meal provided for them on those early release days. So the first one is coming up on December the 10th. 191 00:32:10.260 --> 00:32:22.530 Jeff Arnett: And we're going to try this. This year we think it'll be a great way for our staff to decompress as well as our students to benefit from a little bit of extra time off, because we know that it's been a really hard and challenging semester. 192 00:32:22.890 --> 00:32:29.070 Jeff Arnett: And school year and we want to give them that time that we've heard that they so desperately need. Dr. Leonard. 193 00:32:29.700 --> 00:32:31.920 Tom Leonard: And speaking of decompressing 194 00:32:33.600 --> 00:32:45.480 Tom Leonard: We are closed. Next week, and I mentioned to my staff yesterday. And then I got a bunch of emails from them saying, Please say this to the parents too 195 00:32:46.320 --> 00:32:57.510 Tom Leonard: I told my staff get away from the computer screens and possible for one week just get away from them. You don't have to

answer email every single day during a Thanksgiving break

196 00:32:57.870 --> 00:33:03.300 Tom Leonard: In fact, if somebody emails you. You can even email them and say, Dr. Leonard said I can't answer email but 197 00:33:04.200 --> 00:33:13.800 Tom Leonard: sort of joking, but we really want it to be a break for our staff. We also want to be a break for our kids and want to be a break for the parents and for the whole community. 198 00:33:14.670 --> 00:33:19.860 Tom Leonard: Take that time time off, is how you take care of yourself. Once in a while so 199 00:33:20.310 --> 00:33:29.700 Tom Leonard: Yes, this John Havenstrite said earlier, stay off social media, it will be okay or just do social media light and try to do things that are positive. 200 00:33:30.150 --> 00:33:46.020 Tom Leonard: So I want to mention that. Now we're going to go into questions in a second. And so we're about right at that we go about to about 35 minutes of a presentation but there have been a couple things that have developed recently and I think it is important that I talked about them. 201 00:33:48.120 --> 00:33:54.990 Tom Leonard: Many of you may know, if you don't know every Monday afternoon I'm on a call with several superintendents in the area. 202 00:33:55.650 - > 00:34:05.520Tom Leonard: And we are meeting also with officials from Austin public health from the county and from the city and city of Austin and Travis County. 203 00:34:05.970 --> 00:34:13.380 Tom Leonard: And we get a report from Dr. Escott, he tells us what's going on with the numbers and he tells us what's going on in the community. 204 00:34:13.860 --> 00:34:23.790 Tom Leonard: We also talked to him periodically when something's

happening in our schools and you know he did tell us numbers were going up our numbers are nowhere near like El Paso. 205 00:34:25.350 --> 00:34:27.690 Tom Leonard: Thank goodness, where the numbers are really 206 00:34:29.250 --> 00:34:35.700 Tom Leonard: Significant. In fact, when you look at Dallas, Houston, El Paso, Amarillo 207 00:34:36.300 --> 00:34:45.180 Tom Leonard: Our numbers are actually much lower. But what has happened is they are reallocating some of the medical personnel in Austin to some of those areas. 208 00:34:45.780 --> 00:34:57.090 Tom Leonard: In addition, they are bringing patients and from some of those areas to Austin, because we have room and that has the potential if our numbers keep going up of stressing our system. 209 00:34:57.690 --> 00:35:09.870 Tom Leonard: Dr. Escott's, the one who makes the call and they have moved us into phase four. And here's where people start getting a little confused if you're not watching it carefully, and what the rules are 210 00:35:10.530 --> 00:35:22.290 Tom Leonard: Back way back when, in August. We had these stages and it said, this happens here. This happens here. You may remember it in stage four, we could only be 25% and in stage three, we could only be 50% 211 00:35:22.980 --> 00:35:31.530 Tom Leonard: Remember that was in that first eight weeks period of time. Once we got past that we were past TEAs window and that went out. 212 00:35:32.220 --> 00:35:39.150 Tom Leonard: We're now in a situation from this point forward with the parents that they want in there in if they want remote their remote

213

00:35:39.690 --> 00:35:48.630 Tom Leonard: And we're not at stage four going to 25% so we will stay at the percentages that we are at now and in the 214 00:35:49.560 --> 00:36:05.610 Tom Leonard: recommendations that came out from Austin public health, they did not tell us to go back to 25% even though they are going into stage four it does not save it. In addition, sometimes people ask about athletics. Our athletics will keep going. 215 00:36:06.870 --> 00:36:17.730 Tom Leonard: They still are restricting the percentage of people, we can have who view the games will keep it the current numbers that were out at right now in terms of what we've been doing thus far. So that will keep going. 216 00:36:18.330 --> 00:36:30.960 Tom Leonard: But it is everything I have in front of me now on Monday after Thanksgiving. We'll be back with the same number of kids in person and the same number of kids remote that we had today. 217 00:36:31.320 --> 00:36:43.530 Tom Leonard: And then once we get into that re selection process those percentages may change. Now, Yes, the governor could do this, the governor could do that. Remember in March. He made us all go remote 218 00:36:44.190 --> 00:36:51.570 Tom Leonard: He stated today that that was not his intent. I have to take him at his word. So right now we will not be going all remote on 219 $00:36:52.950 \longrightarrow 00:36:53.730$ Tom Leonard: In the near future. 220 00:36:54.750 --> 00:37:10.560 Tom Leonard: So I just wanted to make sure I least mentioned that, because I know that's on a lot of people's minds. So as I go into the questions, again, these are some of the people who are going to be helping me and I'm going to really get away from this screen. 221 00:37:12.000 --> 00:37:22.560 Tom Leonard: And let many faces be seen for a second here. Okay, I think I got that. And I'm going to ask my principals to show their

faces and 222 00:37:23.910 --> 00:37:27.810 Tom Leonard: I'd like Molly May if you can kind of come in and 223 00:37:29.430 --> 00:37:30.600 Tom Leonard: Help me out here a little bit. 224 00:37:32.250 --> 00:37:38.910 Tom Leonard: And Jeff, you can even show your camera, if you don't mind. Okay, so here we go. I have seen several 225 00:37:39.930 --> 00:37:45.960 Tom Leonard: questions come in one question. It says, can you can you share the PowerPoint. Yes. 226 00:37:48.060 --> 00:37:59.730 Tom Leonard: Claudia tells me that our communications director tells me we record the presentation and we'll post it online tomorrow. So if you missed it, or you want to link you can go show it to somebody and 227 00:38:01.380 --> 00:38:09.000 Tom Leonard: If they weren't able to be here tonight. That's fine. We'll also she says post a link on social media. So both of those things will happen. Okay. 228 00:38:10.800 --> 00:38:18.090 Tom Leonard: There's a couple questions related to quarantine and related to the dashboard. I think I'm going to start 229 00:38:18.660 --> 00:38:30.390 Tom Leonard: Jeff Arnett. I know you were Jeff and Molly You both work a little bit with our team working on that dashboard. Let's start kind of global. And then there's a question specifically connected to the high school so 230 00:38:32.160 --> 00:38:42.810 Tom Leonard: Jeff. The question is in the future. Can we get the current number of students quarantine per campus on the dashboard. Can you you know we've talked about that multiple times in

231 00:38:44.820 --> 00:38:46.710 Tom Leonard: Please share where we landed. 232 00:38:47.040 --> 00:38:55.830 Jeff Arnett: Yeah, that's a continual topic of conversation if not debate internally. If you look at a lot of school districts that have similar dashboards. 233 00:38:56.490 --> 00:39:05.070 Jeff Arnett: The vast majority of them do not report that number. There are a handful that do, but we're one of the districts that has chosen not to report it. And there are 234 00:39:05.880 --> 00:39:19.560 Jeff Arnett: Various reasons for that. We're not hiding anything we really do want to be transparent, but people are naturally curious about how many students are affected or in quarantine maybe an isolation because of some of the positive cases. 235 00:39:20.100 --> 00:39:25.230 Jeff Arnett: And the reason why we don't post it is because that number is larger. As you would imagine. 236 $00:39:25.590 \longrightarrow 00:39:32.280$ Jeff Arnett: If you have a student and you do the contact tracing because that student is positive, there may be a handful. There may be several students 237 00:39:32.700 --> 00:39:41.280 Jeff Arnett: Who are affected, and then have to go into guarantine and that's according to CDC guidelines that 14 day quarantine is not something that we made up. 238 00:39:41.760 --> 00:39:46.290 Jeff Arnett: That's something that is prescribed by the CDC and other agencies and we want to adhere to that. 239 00:39:46.680 --> 00:39:55.920 Jeff Arnett: But most of the quarantines if you look at them are students who are healthy. It's the positive cases those students who are actually ill or affected with the virus.

240 00:39:56,250 --> 00:39:59,940 Jeff Arnett: Those are the ones that we want to focus on and report on our website. 241 00:40:00.420 --> 00:40:08.130 Jeff Arnett: The vast majority of students who go into quarantine. They come back out of quarantine, and they never contract the virus. They're there as a precaution. 242 00:40:08.400 --> 00:40:19.470 Jeff Arnett: It's a safety measure to protect them and to potentially protect other students. So yes, it's an inconvenience to those students because they're not in school. It's an it's an inconvenience to teachers. 243 00:40:20.010 --> 00:40:25.980 Jeff Arnett: But we know that they're going to return to us at some point, and they're going to return healthy so we don't focus on the number in guarantine. 244 00:40:26.370 --> 00:40:37.290 Jeff Arnett: That's also a number that changes literally every day, sometimes even every hour, you've got students who are moving in and out of guarantine, depending upon when close or contact tracing occurred. 245 00:40:37.890 --> 00:40:49.320 Jeff Arnett: And it becomes very difficult to track and trace that number of students and to provide an accurate number on our website. And we know that accuracy is very important to our community. 246 00:40:49.620 --> 00:41:01.080 Jeff Arnett: We can be assured of the accuracy of the positive cases, but that number of guarantines is changing constantly and we want that website to be as up to date as possible which we maintain on a daily basis. 247 00:41:01.680 --> 00:41:17.550 Jeff Arnett: And finally, many of the quarantines are unrelated to a

positive case of school. It may be a relative that may be another friend outside of school. And that's why they're in quarantine. So not

all of those students who are in guarantine are there because of a positive case in our schools. 248 00:41:18.090 --> 00:41:23.430 Tom Leonard: And we did, we are having some conversations on our communication when we send things out. 249 00:41:23.820 --> 00:41:30.360 Tom Leonard: In terms of our letters and communicate, most of that has been copied from TEAs guidelines in terms of how we should be communicating 250 00:41:30.810 --> 00:41:41.280 Tom Leonard: But we have had some seeds to give suggestions from the community that we plan on looking at as soon as we get back from break. Steve, I'm going to get to you, you want to share, Steve. The question. 251 00:41:42.510 --> 00:41:45.030 Tom Leonard: Connected. Another question kind of connected to this. 252 00:41:47.880 --> 00:41:57.930 Tom Leonard: So over time, we've had guite, you know, we don't have a lot of cases, we have about 12 cases. I think at the high school, a couple days ago, there were active cases of COVID 253 00:41:58.800 --> 00:42:04.320 Tom Leonard: But if you add it up over time from when we first started first started, it's it's north of 50 254 00:42:05.160 --> 00:42:17.700 Tom Leonard: And so the question is when you have those cases. How many roughly what does that mean when you get a case. How many kids are quarantined and I know it varies, but I want you to I want them to hear your voice in terms of explaining that and not mine. 255 00:42:18.750 --> 00:42:24.810 Steven Ramsey: So the word there is definitely varies. It's a we get asked by staff by students by parents like 256 00:42:25.320 --> 00:42:34.680

Steven Ramsey: From one case, what's the average. Well, that's pretty difficult and even changes with levels. I know I talked to Mrs Sullivan and Miss Carter a lot and they have more kids on campus and 257 00:42:35.100 --> 00:42:44.550 Steven Ramsey: Then the high school so their numbers may actually be a little bit higher per average when it comes to guarantine. But the high school, depending on what program, it is and if they are remote or in person. 258 00:42:45.780 --> 00:42:54.570 Steven Ramsey: And depending what the directors and coaches have done with their ability to space out and in each and every classroom, we've had, you know, I'd say around 400 quarantines it's about that. 259 00:42:55.080 --> 00:43:11.910 Steven Ramsey: High was about 66-68 cases. Some students may quarantine unfortunately, you know, 35-40 some students will have zero quarantines attached to them and to kind of go along with Dr. Our next point. Sometimes I can get real difficult to explain on a tracker. 260 00:43:13.260 --> 00:43:18.990 Steven Ramsey: And then each case is very, very, very independent and one thing we've noticed with our staff. 261 00:43:20.190 --> 00:43:28.050 Steven Ramsey: You know, working with them when they see a number like 8 on a sheet or four on a sheet is one thing I would say is our communities we feel is being very honest. 262 $00:43:29.340 \longrightarrow 00:43:37.710$ Steven Ramsey: They're being very upfront about what's going on. And we have some fantastic kids a lot of the kids who tested positive or asymptomatic, who were involved with different kids. 263 00:43:38.100 --> 00:43:42.990 Steven Ramsey: Either on campus, mainly off campus and felt like for the, you know, for the health of their family 264 00:43:43.410 --> 00:43:51.210 Steven Ramsey: I need to go get tested as well. And so there's a story behind each and every one. I think that's where it gets difficult. I

looked at Southlake Carol's 265 00:43:51.480 --> 00:43:58.290 Steven Ramsey: Over the weekend, and they try to explain each one and it gets very jumbled up rather guickly. And they all kind of read the same after a while. 266 00:43:58.920 --> 00:44:06.510 Steven Ramsey: But, you know, there's all kinds of reasons why kids going to quarantine. We have had students in quarantine who have tested positive who were 267 00:44:07.080 --> 00:44:20.880 Steven Ramsey: Involved with some of the students who were positive outside of campus. And, you know, Halloween, with Homecoming different things we kind of saw an uptick there for about seven or eight days that seemed like we were sending you know pretty large numbers out each and every day. 268 00:44:22.080 --> 00:44:27.840 Steven Ramsey: And so that's just kind of expected and it's very difficult because we don't know when we go into classrooms. How many students 269 00:44:28.170 --> 00:44:43.050 Steven Ramsey: May be quarantined or not. And remarkably enough as you guys know, as parents, kids who are in classes together sit by their friends. They sit at lunch with their friends. They're usually involved in the same activity with their friends. And so we had a group of kids in the same grade. 270 00:44:44.520 --> 00:44:54.030 Steven Ramsey: Earlier in September, we went in a guarantine and because they had done a lot of things and sports outside of our campus as well as socially. 271 00:44:54.540 --> 00:44:58.710 Steven Ramsey: They tested positive and guarantine and we didn't have any more students so 272 00:44:58.950 --> 00:45:09.240 Steven Ramsey: It gets a little and I'm rambling, a little bit here,

but it's very if you wanted to, you could sit down and each and every case we have students who tested positive because the siblings who came from, from college for labor day weekend. 273 00:45:09.810 --> 00:45:19.680 Steven Ramsey: We have students who test positive because their parents test positive first. And one thing we tried to do. And I think the community has been very good about this. And one thing we stress the high school all the time is 274 00:45:20.430 --> 00:45:32.760 Steven Ramsey: It's a virus. People get viruses and we've tried to alleviate any kind of shame attached to that. And we've actually when we go into rooms, you'll see the assistant principals go in there with homemade six foot sticks. 275 00:45:33.150 --> 00:45:39.510 Steven Ramsey: That kids understand this is a process, they understand that this is how life is.
