



TUITION AND FEES FOR THE 2020-2021 SCHOOL YEAR

GRADES	TUITION	REQUIRED FEES

6 - 8	\$15,372	\$570 Student Supply Fee (Due on the 1st Day of School August 2020)

NEW STUDENT ENROLLMENT FEE

All new students* accepted to Countryside School for the 2020-2021 school year are required to pay a one-time New Student Enrollment Fee as follows:

New Student Enrollment Fee	K - 6	\$1000 (Due 2 weeks after acceptance)
New Student Enrollment Fee	7 - 8	\$ 500 (Due 2 weeks after acceptance)

Failure to pay the New Student Enrollment Fee by the due date will result in the cancellation of admission. This fee is **non-refundable** even if the student does not subsequently attend Countryside or withdraws prior to the end of the academic year.

*The maximum total fee per family is \$2,000, regardless of the number of children in the family ever enrolled.

Quarterly	Four payments of \$3,790	Four payments of \$3,893	- 2 weeks after receipt of tuition and fees contract - June 15, 2020 - September 15, 2020 - January 15, 2021
Monthly (includes supply fee)	Twelve payments of \$1,311**	Twelve payments of \$1,353**	- 15th of every month beginning March 15, 2020 and ending February 15, 2021 (amount of the first payment is the total due to date and is due 2 weeks after receipt of tuition and fees contract)

** The monthly payment amount includes the supply fee. For all other payment options, the supply fee is due on the first day of school in August 2020.

REFUND POLICY

Upon signing the tuition contract, the parents/guardians are financially responsible and obligated for the full amount of tuition. If the student withdraws, the amounts paid, **less the amounts specified below**, will be refunded to the parent/guardian:

If the student has withdrawn, the amount retained is:

Notice given prior to May 1	10% of annual tuition
Notice given prior to June 15	25% of annual tuition
Notice given prior to August 15	50% of annual tuition
Notice given after classes start	50% of annual tuition + prorated tuition for the enrolled period, not to exceed full tuition

If a student is dismissed from Countryside School for academic or behavioral problems, the tuition will be pro-rated to the date of dismissal. Any tuition paid beyond the pro-rated amount will be refunded.

In all cases, the New Student Enrollment Fee is non-refundable and the Student Supply Fee is non-refundable if a student has attended classes.
