

Information for Students and Families

Requirements for Return to Campus:

- To return onsite the week of December 14, all students need to begin a two-week quarantine on November 28.
- All on-campus students need to have one negative test result within the following windows:
 - **Lower school students to test the week of December 7, within seven days of the start of programming on December 14.**
 - **Middle and upper school students test the week of November 30 or December 7.**

Testing Details:

- Families should schedule an on- or off-campus test for their students. Information about on-campus testing (now available for all divisions) is below.
- On campus testing requires pre-registration. Sign up early for choice time slots. We will accommodate walk-ups if possible.
- Please register with student name, DOB, and health information and with parent contact email and phone number.
- Siblings can choose to test at the same campus.
- Please see our [directions for visiting campus](#) for onsite testing.
- Families can choose to pursue PCR testing with their health care providers or a county testing site. For this off-campus testing, parents or guardians must forward electronic confirmation of test results (regardless of a positive or negative test) to nurse@nuevaschool.org with the subject line: "Test Results" as soon as they are received, and no later than Saturday, December 12.

Additional Information:

- As testing on campus will be happening during remote school hours, teachers expect students may need to miss class and will be flexible.
- All on-campus faculty, staff, and contractors continue to test weekly.

contact tracing, including administering more than 300,000 tests onsite and in clinic. Carbon provides a PCR test via oral (throat) or nasal (mid) swab with test turnaround times in 48-72 hrs. Registration and reporting is automated, online, and via email or text, including support for contact tracing and coordination with public health.

Curative offers a PCR test with millions of tests successfully administered and reported in California and across the country. Testing is all they do. There is a non-invasive oral/mouth swab sample collection (not throat swab) accessible to children and adults. They offer a 24- to 48-hour test turnaround time. Registration and reporting is highly automated, online, and via email or text with support seven days a week, including support for contact tracing and coordination with public health.
