Graduation rate rises, among top in Puget Sound area

The Office for the Superintendent of Public Instruction recently released the <u>on-time graduation rates</u> for school districts across the state. Lake Washington's on-time rate for the class of 2015 was 92.3%, up from 90.2% the year before. A recent <u>Seattle Times article</u> about on-time graduation rates in the state cited seven school districts in the Puget Sound with rates above 92% - including Lake Washington. The other districts are Issaquah, Snoqualmie Valley, Steilacoom, Vashon Island, Bainbridge Island and Mercer Island.

High school parents: New chickenpox (varicella) vaccine regulations
School vaccination regulations in Washington state have changed for
the upcoming 2016-17 school year. The Washington State

Department of Health now requires two doses of chickenpox
(varicella) vaccine for all students in grades K through 12, previously
required for K-8. Students who do not have two doses of vaccine by
the start of classes in September could be excluded from school.

State testing starts soon

All Washington public school students in grades 3-8 are assessed in English Language Arts (ELA) and math using Smarter Balanced Assessments (SBA). Students in grades 5 and 8 are also assessed in science using the Measurement of Student Progress (MSP). High school students take the SBA for ELA and math. They also take an End of Course (EOC) exam in Biology. Students in LWSD will begin testing at the end of March. Each school has a different testing schedule: your student's school will provide that information. Learn

New for 2016:

- Tenth grade students may now access the Math SBA:
 Tenth grade students may now also take the Smarter Balanced math assessment. Tenth grade students should have passed or be taking Algebra 2 before taking the SBA in math. Students who score a 3 or 4 on the SBA in 10th grade will not need to take that exam during 11th grade. Read more.
- New Transcript Notation: Effective April 2016, the Washington State Official Transcript has been updated to include a notation when students receive a level 3 or 4 on the High School Smarter Balanced Assessments. This new notation will read, "WA STATE HIGHER ED PLACEMENT AGREEMENT," with ELA and/or MATH after it. If a student has not taken the SBA, or if they scored a 1 or 2, there will be no notation. Safety Spotlight: What is "Shelter-in-Place"?

Schools practiced a "Shelter-in-Place" drill in February. Shelter-in-Place in the school setting is designed to protect building occupants from a hazardous gas, particulate or other biohazard in the outside air. These events most likely would happen quickly and perhaps without much warning. An example is a truck carrying ammonia that overturns, releasing a poison cloud traveling through the air.

Schools identify locations for gathering students and staff together, such as the cafeteria, commons or gymnasium. The idea is to keep the hazard that exists in the outside air from coming into the building. The best way to do that is to cover and seal the operable windows and doors in the occupied spaces. Consolidating into central locations helps reduce the number of openings that need to be sealed.
