Registered voters will receive their ballots for the April Special Election in early April. King County Elections is scheduled to mail the ballots on April 6. Ballots must be returned or postmarked by April 26. The Lake Washington School District Proposition No. 1 Bonds to Reduce Overcrowding and Enhance Student Learning Environments is the only item on the ballot. #### College & Career Readiness Task Force work continues

In March 2015, the district convened a College and Career Readiness Task Force composed of broad representation of staff and parent members. The overall purpose of the task force is to study, analyze, and make recommendations regarding impacts of the new state 24-credit requirements and ways to expand options for grades 9-12. Additionally the task force will study and analyze school schedule and start time implications.

Phase I includes a review of the 24 credit graduation requirements and development of potential ways to increase flexibility for students. Task force members just completed a series of listening sessions to get feedback on specific scheduling options. Phase II includes a review of school start times, K-12. We anticipate having final recommendations by the end of December 2016.
