RE: Recommendation for Award of Landscaping Improvements

On July 23, 2020 the district advertised a Request for Proposals for Landscaping Improvements in the local publication, the Rochester Post, and posted RFP documents on the Purchasing pages of the district's website, the State of Michigan procurement website, and BidNet Direct. The district received six (6) responses on the due date and bidding closed on August 6, 2020. A virtual public bid opening was conducted online on August 6, 2020 at 2:30pm.

The scope of the project includes landscaping improvements at two (2) school buildings: Reuther and Van Hoosen Middle Schools.

Proposals were evaluated by the Director of Capital Projects & Facilities, Pete Muscio, and consultants at Grissim, Metz, and Andriese Associates, a landscaping architecture firm.

The proposal documents are on file in the Purchasing Department. The proposal summary and consultant recommendation is attached. The source of funding is the 2015 Bond.

Based on this information, we recommend the District award the Landscaping Improvements 2020 project to Sinacori Landscaping Inc., in the amount of \$139,011.

It is our recommendation that Sinacori Landscaping, Inc. be awarded the contract for \$139,011 to complete the 2020 landscape improvements at Van Hoosen Middle School and Reuther Middle School. This recommendation is based on our review of all submitted bids. Sinacori's bid appears to be consistent with the project's scope and anticipated costs. A summary of the bids received and our evaluation is as follows:

Premier Group Associates (\$183,443.25)

- Bid was the highest amount

Backer (\$152,632.00)

- Bid was complete but significantly higher than Sinacori Landscaping, Inc.

KLM (\$119,145.50)

- Awarded contract for the 2019 landscape improvements. Their performance-to-date has been below average. A variety of issues on the 2019 work has resulted in a majority of the work having to be redone.

RNA (\$106,621.00)

- Their company's website shows that they are primarily a facilities management company that has a landscape division, raising the concern that they have the experience with projects of this size and complexity.

Dalco (\$79,996.15)

- Base Bid was significantly lower than anticipated and the other bids as a result of bidding errors on proposal form
- Experience with projects of this size and complexity were not prevalent on their company website or attached response
