

Policy A13 – Freedom of Information

1. Introduction

- 1.1 This policy sets out the classes of information that the University of Brighton Academies Trust and/or its academies¹ publish and the terms on which that information may be made available to those who request it. It is based on the generic model publication for academies scheme prepared and approved by the Information Commissioner.

2. Principles

- 2.1 This publication scheme commits the Trust to make information available to the public as part of its normal business activities. The information covered is included in the classes of information mentioned below, where this information is held.
- 2.2 The scheme commits the Trust:
- To proactively publish or otherwise make available as a matter of routine, information, including environmental information, which is held by the Trust and falls within the classifications below;
 - To specify the information which is held by the Trust and falls within the classifications below;
 - To proactively publish or otherwise make available as a matter of routine, information in line with the statements contained within this scheme;
 - To produce and publish the methods by which the specific information is made routinely available so that it can be easily identified and accessed by members of the public;
 - To review and update on a regular basis the information the Trust makes available under this scheme;
 - To produce a schedule of any fees charged for access to information which is made proactively available;
 - To make this publication scheme available to the public.

3. Classes of information

- 3.1 The classes of information that the Trust publishes includes:
- **Who we are and what we do**
Organisational information, locations and contacts, constitutional and legal governance.
 - **What we spend and how we spend it**
Financial information relating to projected and actual income and expenditure, tendering, procurement and contracts.
 - **What our priorities are and how we are doing**
Strategy and performance information, plans, assessments, inspections and reviews.
 - **How we make decisions**
Policy proposals and decisions. Decision-making processes, internal criteria and procedures, consultations.
 - **Our policies and procedures**
Current written protocols for delivering our functions and responsibilities.

- **Lists and Registers**
Information held in registers required by law and other lists and registers relating to the functions of the Trust.
- **The Services we Offer**
Advice and guidance, booklets and leaflets, transactions and media releases. A description of the services offered.

3.2 The classes of information the Trust publish will not generally include:

- Information the disclosure of which is prevented by law, or exempt under the Freedom of Information Act, or is otherwise properly considered to be protected from disclosure.
- Information in draft form.
- Information that is no longer readily available as it is contained in files that have been placed in archive storage, or is difficult to access for similar reasons.

4. Procedures

4.1 The method by which information published under this scheme will be made available

4.1.1 The Trust will indicate clearly to the public what information is covered by this scheme and how it can be obtained.

4.1.2 Where possible, the Trust will provide information on its website. Where it is impracticable to make information available on a website or when an individual does not wish to access the information by the website, the Trust will indicate how information can be obtained by other means and provide it by those means.

4.1.3 In exceptional circumstances some information may be available only by viewing in person. Where this manner is specified, contact details will be provided. An appointment to view the information will be arranged within a reasonable timescale.

4.1.4 Information will be provided in the language in which it is held or in such other language that is legally required. Where the Trust is legally required to translate any information, it will do so.

4.1.5 Obligations under disability and discrimination legislation and any other legislation to provide information in other forms and formats will be adhered to when providing information in accordance with this scheme.

4.2 Charges which may be made for Information published under this scheme

4.2.1 The purpose of this scheme is to make the maximum amount of information readily available at minimum inconvenience and cost to the public. Charges made by the Trust for routinely published material will be justified and transparent and kept to a minimum.

4.2.2 Material which is published and accessed on a website will be provided free of charge.

4.2.3 Charges may be made for information, subject to a charging regime specified by Parliament.

4.2.4 Charges may be made for actual disbursements incurred such as:

- photocopying (10p per A4 sheet)
- postage and packaging (actual cost of 2nd class postage)
- the costs directly incurred as a result of viewing information (£25 per hour of staff time)

4.2.5 If a charge is to be made, confirmation of the payment due will be given before the information is provided. Payment may be requested prior to provision of the information.

4.3 Written Requests

- 4.3.1 Information held by the Trust that is not published under this scheme can be requested in writing, when its provision will be considered in accordance with the provisions of the Freedom of Information Act.

4.5 The method by which information published under this scheme will be made available

- 4.5.1 The table in Appendix 1 identifies the information which meets the requirements of the Information Commissioner.

5. Refusing requests and exemptions to the law

- 5.1 There will be occasions when a decision is taken to refuse a request for information. Examples of when this could happen are:

- it would cost too much or take too much staff time to deal with the request
- the request is vexatious
- the request repeats a previous request from the same person

- 5.2 The Freedom of Information Act also contains a number of exemptions that allow the Trust to withhold information from a requester. Examples of this type of exemption are:

- if a disclosure could prejudice a criminal investigation
- if commercial interests could be prejudiced
- if it would be contrary to the General Data Protection Regulation (2018) or Data Protection Act (2018)

- 5.3 When a decision is taken to apply an exemption, a refusal notice will be issued giving details of the reason for the decision. Details of the Trust internal review process will be provided.

6. Complaints

- 6.1 The Trust has an internal review process for dealing with any complaints received in relation to Freedom of Information requests.

6.3 Internal review process

6.3.1 An internal review will be conducted by a staff member who did not deal with the original request. The member of staff conducting the review will usually be a more senior member of staff than the staff member who dealt with the request.

6.3.2 The reviewer will:

- make a fresh decision based on all the available evidence that is relevant to the date of the response, not just a review of the first decision
- ensure that the review takes no longer than 20 working days in most cases or 40 in exceptional circumstances
- consider whether circumstances may have changed which mean that the original concerns about disclosure no longer apply

6.3.3 If a complainant is not satisfied with the outcome of the review then a complaint can be made to the Information Commissioners Office.
