Monthly Report 16DEC20

All figures and outcomes are based on the date of this report 10DEC20

Flying: We have flown than 5 missions and less than 10 hours since the last given report on 19NOV20.

Aircraft Status:

- N739HK is currently down for paint correction and we will be trying to get avionics work done this month as well.
- N1917L is currently in good condition and is current on all required tests and inspections. We are using N1917L in a backup capacity at the moment to support the program when HK is unavailable for any reason.

Ground Classes Status:

• Ground Classes are wrapping up.

Ongoing Business:

- SAMS Academy will now be an official affiliate program with Spartan School of Aeronautics. We are extremely excited to see what this partnership will bring to the future of SAMS and Spartan. Thank you for your continued support!
- SAMS has had the opportunity to participate in an amazing program that rescues pets and transports them to permanent homes. This program could potentially offset some of our operational costs and promises to bring some amazing publicity to our school. We are working with PED to ensure we can continue the relationship we have formed with Barkhouse (the organization responsible for organizing these pet rescues). One important note: we are NOT making these missions a priority and we will only participate when our mission overlaps and makes a flight feasible. Our primary objective is safe and efficient flight training, if we can weave in a real world aspect and enrichen the experience for our students we will.

Student Outcomes:

• All of last year's seniors finished their Private Pilot Checkride and our first for this year also completed a checkride. Thus far SAMS has a 100% pass rate.

Outlook for Next Month:

• The start of next semester will mark the beginning of our recreational pilot flight training. We hope that the reduced flight hours for recreational pilot will allow us to accelerate flight training and turn out even more quality pilots in the very near future.

Aviation Finance Report:

Purchases:

• Amazon: \$2008.34

This purchase was for drone lab supplies (tools, safety equipment) and EFB devices for the program. We purchased 5 Samsung tablets to be used in the flight program as Electronic Flight Bags for the students.

Flight Expenses/Variable Costs:

- **Fuel:** This last month we have very few flight hours. For world fuel the invoiced total 11/19/20 through today is \$424.51. The dates reflect the invoice date, not necessarily the service dates.
- **Maintenance:** Awaiting invoice for annual/100 hr inspections. Based on historical data cost per flight hour for maintenance is approximately \$20.00

Fixed Costs:

- Hangar Rental:
 - o \$325.00 per month for KAEG
 - o \$235.00 per month for KBRG
 - o \$560.00 per month **total** for two hangars.
- Insurance: Annual Premium \$ 8,549.00

GOVERNING COUNCIL RESOLUTION No. 2020/2021-0004 Commitment of Fund Balances School Year 2020/2021

WHEREAS, the Southwest Aeronautics, Mathematics and Science Academy Governing Council approved a revision to their Fund Balance Reporting Policy per GASB 54 on October 23, 2012; and

WHEREAS, Southwest Aeronautics, Mathematics and Science Academy's Fund Balance Reporting Policy assigns the Governance Council of the Southwest Aeronautics, Mathematics and Science Academy the authority to set aside funds for a specific purpose; and

WHEREAS, the Southwest Aeronautics, Mathematics and Science Academy Governing Council met in regular session on November 15, 2018 and authorized Administration to move forward with the sale of the Fixed Asset described as a Diamond DA-40 aircraft with serial number N806ER S/N 40.317; and

WHEREAS, per the New Mexico Public Education Department's approval of the sale of N806ER, any proceeds from the sale can only be used to "facilitate the restoration of the school's other aircraft"; and

WHEREAS, proceeds from the PED approved sale of N806ER in the amount of \$117,800.00 were received by the Southwest Aeronautics, Mathematics and Science Academy on August 30, 2019 and these amounts remained unspent as of June 30, 2020.

NOW, THEREFORE, BE IT RESOLVED by the Southwest Aeronautics, Mathematics and Science Academy Governing Council that:

1. \$117,800.00 of the Fiscal Year 2021 fund balance of the Operational Fund (11000) be set aside for the sole purpose of uses as allowed by the PED for the Aviation program.


