  - 1. <u>Approval of Revised Plans</u>: RESOLVED, That the Board approves the Health and Safety Plan 3.0, the Revised Reopening Education Plan, and the Revised Athletics & Activities Health and Safety Plan 4.0, all dated December 16, 2020, in substantially the form presented, with adjustments and modifications as deemed necessary by the Superintendent.
  - 2. <u>Approval of Resumption of Hybrid Model</u>: RESOLVED, That the District resumes the Hybrid (Blended) Mode of Instruction as described in the Revised Reopening Education Plan on a staggered basis, with elementary students resuming Hybrid Instruction on January 11, 2021 and secondary students resuming Hybrid instruction on January 21, 2021; prior findings and approvals by the Board are only rescinded to the extent they are inconsistent with this resolution.

3. <u>Approval of Resumption of Athletics</u>: RESOLVED, That District athletic activities resume on January \_\_\_, 2021 except that those sports designated as "higher risk" by the PIAA/NFHS shall not be permitted so long as the level of community transmission is "substantial" as designated by the Pennsylvania Department of Education.
