- V. New Business for Board Consideration and Action
1. Approval of Revised Plans: RESOLVED, That the Board approves the Health and Safety Plan 3.0, the Revised Reopening Education Plan, and the Revised Athletics & Activities Health and Safety Plan 4.0, all dated December 16, 2020, in substantially the form presented, with adjustments and modifications as deemed necessary by the Superintendent.
 2. Approval of Resumption of Hybrid Model: RESOLVED, That the District resumes the Hybrid (Blended) Mode of Instruction as described in the Revised Reopening Education Plan on a staggered basis, with elementary students resuming Hybrid Instruction on January 11, 2021 and secondary students resuming Hybrid instruction on January 21, 2021; prior findings and approvals by the Board are only rescinded to the extent they are inconsistent with this resolution.

3. Approval of Resumption of Athletics: RESOLVED, That District athletic activities resume on January __, 2021 except that those sports designated as “higher risk” by the PIAA/NFHS shall not be permitted so long as the level of community transmission is “substantial” as designated by the Pennsylvania Department of Education.
