A regular meeting of the Board of Education of Independent School District Number One of Tulsa County, Oklahoma, was held on October 13, 2020, commencing at 6:30 p.m., conducted using videoconference pursuant to Title 25, Section 307.1 of the Oklahoma Statutes, as amended by Senate Bill 661. OPENING EXERCISES

Ms. Stacey Woolley, president of the Board of Education, called the meeting to order, roll called, and declared that a quorum of the board was present; therefore, the meeting was qualified to consider the agenda items. The flag salute was led by students of Peary Elementary, Nathan, Carter, and Cruz Thomas.

Dr. Gist requested that the action agenda items be moved earlier on the agenda immediately following the approval of the minutes to honor the time of the medical experts participating in the meeting and the community members wishing to speak to item F.2.

Board Member Croisant made a motion to adopt the agenda with the requested change and the motion was seconded by Dr. Jerry Griffin. President Woolley called on Mr. John Huffines who signed up to speak to items F-1. And F-2. Dr. Gist and staff answered questions of the board.

In the introduction of this item Superintendent Gist spoke to the families, staff, and community in response to their feedback and concerns and addressed the considerations that went into the consideration of this item and the development of the recommendation.

A recess of the meeting was taken from 11:16 p.m. to 11:29 p.m. due to technical difficulties.

A motion was made by Ms. Suzanne Schreiber to send all elementary students back to school on 11/16 fully in person 4 days a week. In addition, Pre-K and K grades would go back to school fully in person 4 days per week on 11/9. The motion was seconded by Mr. John Croisant to allow for discussion by the board.

The motion <u>failed</u> by the following vote: AYE: Suzanne Schreiber; NAY: Jerry Griffin, Shawna Keller, John Croisant, Jania Wester, Jennettie Marshall, and Stacey Woolley; ABSTAIN: None.

A motion was made by Dr. Jerry Griffin to send all students back to school fully in person 4 days per week, with the option to remain in virtual learning. Pre-K and K grades would return on 11/9. Grades 1-12 would return on 11/16/2020. The motion was seconded by Ms. Suzanne Schreiber to allow for discussion by the board.

The motion <u>failed</u> by the following vote: AYE: Jerry Griffin; NAY: Suzanne Schreiber, Shawna Keller, John Croisant, Jania Wester, Jennettie Marshall, and Stacey Woolley; ABSTAIN: None.

Ms. Schreiber made a motion to put this matter as an agenda item for information next Monday, October 19 and to bring it back to vote the following week at the next regularly scheduled board meeting. After discussion Ms. Suzanne Schreiber withdrew her motion.

Board Member Schreiber made a motion to have a running agenda item for a COVID- 19 update to include data for our district schools, local surrounding districts, and national information and numbers being gathered at every future board meeting. The motion was seconded by Board Member Croisant. The motion passed by the following vote: AYE: Suzanne Schreiber, John Croisant, Shawna Keller, John Croisant, Jania Wester, Jennettie Marshall, and Stacey Woolley; NAY: None; ABSTAIN: None.

Superintendent Gist and staff agreed to provide data updates on future agendas to help the board monitor the situation.

A motion was made by Ms. Suzanne Schreiber for PK and K grades to return to school fully in person 4 days per week on 11/9 and 1-3 grades to return fully in person 4 days per week on 11/16/2020. Board President Woolley seconded the motion to allow for discussion.

Ms. Suzanne Schreiber withdrew this motion to restate it as follows. Motion for Pre-K to return 4 days per week on 11/9 and 1-3 grades to return the following week of 11/16 to include weekly updates on COVID-19 data with the remaining grades to continue in distance learning through the week of 11/16. The motion was seconded by Mr. John Croisant.

After discussion, Dr. Jerry Griffin asked Board Member Schreiber to clarify her motion along with the dates. Ms. Suzanne Schreiber restated her motion as follows:

A motion was made by Ms. Suzanne Schreiber for grades Pre-K-3 to return fully in person 4 days a week, which means students will be attending in person Monday, Tuesday, Thursday, and Friday, with Wednesdays to remain as distance learning days. Pre-K and K students will return fully in person on 11/9 and grades 1-3 will return fully in person on 11/16. In addition, families will continue to have the option to keep their children in distance learning as they choose and Care and Connect will be available for students who need it the most and as staff are available to provide it. The motion was seconded by Dr. Jerry Griffin. The motion failed with the following vote: AYE: Jerry Griffin, Suzanne Schreiber, Stacey Woolley; NAY: Jennettie Marshall, Jania Wester, John Croisant, Shawna Keller; ABSTAIN: None; ABSENT: None.

After board discussion and clarification on the previous motion, Ms. Suzanne Schreiber made an additional motion for the board to once again consider for grades Pre-K-3 to return fully in person 4 days a week, which means students will be attending school in person Monday, Tuesday, Thursday, and Friday, with Wednesdays to remain as distance learning days. Pre-K and K students will return fully in person on 11/9 and grades 1-3 will return fully in person on 11/16. In addition, families will continue to have the option to keep their children in distance learning as they choose and Care and Connect will be available for students who need it the most and as staff are available to provide it. The motion was seconded by Ms. Shawna Keller and the motion passed by the following vote: AYE: John Croisant, Shawna Keller, Jerry Griffin, Suzanne Schreiber; NAY: Jennettie Marshall and Jania Wester; ABSTAIN: None; ABSENT: None.

A motion was made by Ms. Suzanne Schreiber to table all remaining items on the agenda to include the remainder of item F.2 until the next Board meeting on October 19, 2020. Ms. Jennettie Marshall seconded the motion. Discussion took place among the board and staff.

Ms. Suzanne Schreiber modified the motion to table the remainder of item F.2 until October 19, 2020. Mr. John Croisant seconded the motion and the motion <u>passed</u> with the following vote. AYE: Suzanne Schreiber, Shawna Keller, John Croisant, Jania Wester, Jennettie Marshall, and Stacey Woolley; NAY: Jerry Griffin.
