Friday, Oct. 2, 2020

Due to a change in county COVID-19 cases, Robbinsdale Area Schools announced plans to transition PreK and elementary students to a hybrid learning model, beginning Nov. 9, and secondary students remaining in distance learning. Middle and high school students could possibly change learning models on Tuesday, Jan. 26 - based on the model that aligned with current COVID count data.

Robbinsdale Area Schools emailed families clarifying childcare programming.

Dr. Stephanie Burrage, Interim Superintendent of Robbinsdale Area Schools, shared a video message about the decision to remain in Distance Learning PLUS.

Wednesday, Nov. 18, 2020

Governor Walz announces Executive Order 20-99, putting new restrictions in place.

Wednesday, Dec. 16, 2020

Governor Walz announced school districts can transition elementary students to an in-person learning model beginning Jan. 18, 2021.

Robbinsdale Area Schools emailed families outlining information the governor shared.

Minnesota Department of Education (MDE) released updated guidance to schools in the Safe Learning Plan.

Monday, Dec. 21, 2020

MDE released clarifications to the Safe Learning Plan.

Robbinsdale Area Schools emailed families clarifying information and shared an FAQ sheet.

Wednesday, Dec. 23, 2020

Human Resources will determine how many staff are needed in each building, based on registrations for 281 Distance Learning School.

Week of Jan. 4, 2021

The Incident Command team's recommendation will be reviewed by Cabinet. The plan will be communicated with families.

Friday, Aug. 21, 2020

The District shared additional information on decision-making factors, the hybrid learning model, transportation opt-out, 281 Distance Learning School and county COVID-19 data review periods.

Friday Sept. 18, 2020

The District reiterated that it was preparing for a potential learning model shift for all students on Oct. 19.

Tuesday, Oct. 27, 2020

Due to a change in county COVID-19 case numbers, the transition date to transition PreK and elementary students to a hybrid learning model would begin Nov. 16 with tiered start dates. Our regional team of health experts supported our transition plan.

Thursday, Nov. 5, 2020

Robbinsdale Area Schools announced plans to remain in distance learning for all students. The regional team of health experts no longer supported the transition plan.

Friday, Nov. 13, 2020

Information about Student Supports Centers is shared with families.

Thursday, Nov. 19, 2020

Robbinsdale Area Schools emailed families about the steps school districts need to take to help prevent and contain the novel coronavirus over the next four week: youth and high school sports put on pause; in-person early childhood and community education classes paused; school facility rentals paused.

Friday Dec. 18, 2020

Robbinsdale Area Schools emailed families with additional information along with sharing an upcoming deadline to register for (or opt out of) 281 Distance Learning School.

Tuesday, Dec. 22, 2020 (3 p.m.)

Deadline to register for (or opt out of) 281 Distance Learning School.

Monday, Jan. 4, 2021

The District's Incident Command team will meet to develop a learning plan recommendation.
