

Program Overview

The McCann Technical School Practical Nursing Program is a full-time program of study that leads to a practical nurse certificate and entitles the graduate to sit for the National Counsel Licensing Examination for Practical Nurses (NCLEX-PN). The student who passes the NCLEX-PN becomes a Licensed Practical Nurse (LPN) and is qualified to work as an entry-level licensed practical nurse. The Practical Nursing Program is ten months in length. Classes start in January and graduation is held at the end of November. Most classes, laboratories, and clinical experiences will take place Monday through Friday, 8:00 a.m. to 2:45 p.m. However, in order to provide a complete and well-rounded curriculum, a limited number of clinical experiences will be planned for 7:30 a.m. to 2:00 p.m. and may also be held in the evening and/or on weekends. The program meets the requirements of the Massachusetts Board of Registration in Nursing for providing at least 1080 hours of instruction, a minimum of 945 of which are nursing courses. At least 540 hours of the nursing courses consist of clinical experience. In order to meet the above requirements, attendance at all classes, laboratories, and clinical experiences is mandatory. Students whose absences bring their attendance below the above requirements will not be allowed to continue in the program.

The mission of McCann Technical School is to graduate individuals who are technically skilled and academically prepared to meet the challenges of a global economy. Our vision is dedicated to being the recognized leader of quality technical education in the Commonwealth.

The mission of the McCann Practical Nursing Program is consistent with the mission of the parent institution while focusing specifically on practical nursing. The McCann Practical Nursing Program is designed to prepare the graduate for competent, ethical, entry-level practice in the care of diverse populations with common or stable health care needs in structured health care settings.

Admission Policies

All candidates for admission to the Practical Nursing Program are required to provide satisfactory evidence of secondary school graduation or its equivalent. Applicants are required to submit the following documents:

- ◆ Completed application form.
- ◆ Official high school transcript or official verification of HSE (High School Equivalency) and official GED/HiSET transcript of scores. Applicants must

have achieved a grade of C or above in mathematics and English.

- ◆ Official college or postsecondary transcripts if applicable.
- ◆ Essay for selecting your program.
- ◆ Three (3) letters of reference from guidance counselors, teachers, employers or other professionals.
- ◆ TEAS exam fee.

Candidates are required to submit their application and exam fee in order to be scheduled for the Test of Essential Academic Skills (TEAS) and must score at or above the national program mean to be further considered for admission to the program. The test will be administered at McCann and candidates will be given instructions for obtaining study materials.

- ◆ Students who do not meet the minimum qualifications as evidenced by the TEAS entrance test may retake the exam provided one month has passed and an additional fee has been paid.
- ◆ Qualified students will be interviewed and will submit a second short essay to be written on the day of the interview.
- ◆ Of those students who qualify, admission slots will be granted first to those whose transcripts, TEAS scores, references, interview and writing sample are predictive, in the opinion of the admissions committee, of the greatest potential for success in the program.

Transfer Credits

The program coordinator will evaluate credits for transfer on an individual basis for the following courses: PN 101 Anatomy & Physiology and PN 102 Human Growth & Development. To transfer Anatomy & Physiology I & II, the applicant must have attained a grade of B- or higher and credits for transfer must have been earned within five (5) years of entrance into the Practical Nursing Program. To transfer Human Growth & Development, the applicant must have attained a passing grade and credits for transfer must have been earned within ten (10) years of entrance into the Practical Nursing Program. The applicant must also submit a copy of the course syllabus or catalog course description in addition to an official transcript.

The program does not provide advanced placement or course exemptions for students who have successfully completed a Certified Nursing Assistant (CNA) program.

Accepted Students

Prior to official enrollment, all accepted applicants must give permission for a Criminal Offense Record Information (CORI) investigation pursuant to the Criminal Record Information Act (CORI) as per Massachusetts General Laws. Final admission to the program is contingent upon a satisfactory CORI. A court record/past conviction may present a barrier to eligibility for licensure as a licensed practical nurse (LPN). Applicants with a court record/past conviction are advised to carefully review their personal circumstances and the Good Moral Character Licensure Requirement of the Massachusetts Board of Registration in Nursing (Licensure Policy 00-01) to determine their eligibility to meet legal qualifications for nurse licensure in Massachusetts. Applicants may wish to consult an attorney. A second CORI will be required by our clinical sites during Term III.

Some of our clinical sites require that our students submit to a national criminal background check by fingerprinting. If required, practical nursing students must complete this through the State Applicant Fingerprint Identification System (SAFIS) and further instructions will be given later in the year.

Health Documentation

Prior to the first day of class, all admitted practical nursing students are required to provide documentation of the following:

- ◆ Current physical exam (within 3 months **prior to** the first day of class).
- ◆ Two doses measles, mumps and rubella (MMR) vaccine **or** immunity by blood titer (must submit lab results).
- ◆ One dose tetanus, diphtheria, pertussis (Tdap) vaccine within the last 10 years.
- ◆ One dose tetanus, diphtheria (Td) if it has been more than 10 years since the Tdap.
- ◆ Hepatitis B series.
- ◆ Two doses varicella vaccine **or** immunity by blood titer (must submit lab results).
- ◆ Current Tuberculin Skin Test (TST). Students must keep TST current during the course of the program.
- ◆ One dose meningococcal for students 21 years of age or younger (waiver form available).
- ◆ Flu vaccine (one dose is required before entrance into the program; another will be required in the fall).

- ◆ All immunization requirements must be completed by the first day of class and kept current throughout the program. **Failure to keep requirements current will result in ineligibility to attend clinical experience.**
- ◆ McCann will follow the current immunization recommendations of the Massachusetts Department of Public Health.

CPR Requirements

Accepted students must hold current American Heart Association or Red Cross certification in cardio-pulmonary resuscitation (CPR) at the health-care provider level prior to the first day of class. Certification must be valid for the duration of the program.

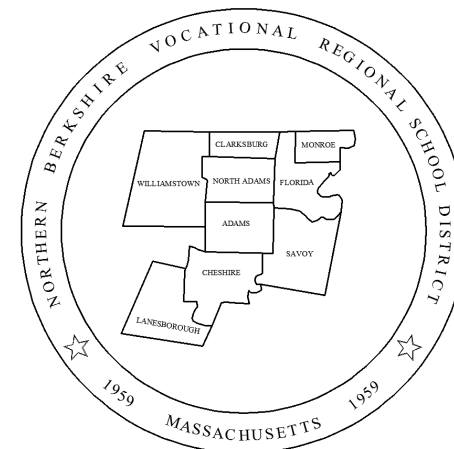
