Wellness at Haverford 2020-2021

When to Stay Home

*If you have NOT completed the COVID-19 symptom tracker for your son

*If your son has NOT passed the COVID-19 symptom tracker in your Magnus Health account

Additionally, if he experiences any of the following symptoms:

- Temperature equal to or greater than 100.0 o F in the preceding 24 hours
- Respiratory symptoms related to any undiagnosed illness
- Vomiting within the previous 12 hours
- Diarrhea within the previous 12 hours
- Undiagnosed itchy, red, weepy eyes
- Undiagnosed skin rash

*Note that this is not a comprehensive list; if you are unsure whether you should send your son to school, please contact our school nurses, or your son's physician.

REPORTING ILLNESS

The Health Center monitors absenteeism to determine both the overall health and well-being of the community, as well as the need for supportive care upon returning to school.

All absences related to any symptoms or illness are to be reported to the Health Office @ 484-417-2714 by 8:30 a.m. for **ALL STUDENTS in ALL DIVISIONS.**

All other absences are to be reported to your division office.

- Lower School Attendance Line: Ext. 1957
- Middle School Attendance Line: Ext. 1968
- Upper School Attendance Line: Ext. 1959

Please complete the COVID-19 screening APP daily while your son is **absent** from school daily by 8:30 a.m. (if your son is attending school virtually while absent from in-person attendance the COVID-19 screening is to be completed).

Preparations for Return to School

A doctor's note is required for any student dismissed from school with fever at or above 100.4 degrees.

Your son should be:

- Fever-free for a full 24 hours without the use of fever-reducing medication (Please do not medicate your son with fever-reducing medications prior to the school day)
- Not experiencing any symptoms listed in "When to Stay Home" guidelines
- Compliant with **Montgomery County Department of Health COVID-19 Exclusion and Return to School Requirements** available [Here](#)
- Compliant with **Pa DOH Traveler's website COVID-19 recommendations for quarantine after travel outside of the Commonwealth of PA** [Here](#)

- Feeling well rested and ready to learn and tolerating a full diet before returning to the classroom

When to Contact the Health Center

Confirmed case of COVID-19

Confirmed exposure to COVID-19 case

Submit and confirm receipt of COVID-19 test results related to travel outside of Commonwealth of PA during school year.2020-2021.

If your son has been diagnosed with a communicable illness

If your son is diagnosed with a health condition that may impact his learning, or his ability to participate fully in the life of the school

We understand that a sudden change in health or a prolonged illness will require a comprehensive plan of care including physical, emotional, and learning support.
