5. DISCUSSION AND POSSIBLE APPROVAL OF NEW EDUCATIONAL SPECIFICATIONS FOR KILLINGLY MEMORIAL SCHOOL PROJECT

Town Manager, Mary Calorio shared with Board members the rationale for the revised ed specs for the KMS project/renovation. The proposed revised ed specs reflect a more comprehensive, encompassing renovation project when compared to the original project filed in June. The original project focused on the removal and replacement of the KMS modulars, at a cost of \$16,550,000 and a Town share of \$7,500,000 with a 60% reimbursement from the State.

The State School Construction office suggested that the Town expand the project to include many needed renovations to the main building. Substantial improvements and renovations to the main building would include; replacement of the HVAC system, replacement of the electrical system, full renovation of the cafeteria kitchen, installation of a fire suppression system, replacement of hallway floors, abatement of all hazardous materials, and final ADA requirements.

The increase to renovate as new, is \$17,450,000 for a total of \$34,000,000 with a 72% reimbursement rate by the State. This would be a substantial economic savings to the Town. The Town share would be \$9,520,000.

The State School Construction Office will keep the expanded KMS project on the current year priority list if the Town Council authorizes funding prior to December 15, 2020.

An Architect was already selected. A construction firm and construction manager will be secured for the project.

If the project is approved by the Governor's office and State legislators, renovations would most likely begin in 2022 with completion expected during the 2024-25 school year.

The Town Council is holding a Special Virtual meeting/Public Hearing on Saturday, December 12 at 1:00 to consider and make action on an ordinance to amend the appropriating and borrowing authorization for the KMS school project.
